As I mentioned previsouly, if we do deicde to go ahead with some form of a China trade mission, they are very eager to assist us in setting up meetings and making arrangements. They are very interested in having us to visit some of their underground operations, as the "reputation" of underground mines in China does not reflect how they conduct mining. I tried to explain to him that government officials cannot accept these types of offers - but I would ensure my supervisor was aware of the offer.

To develop underground coalmines in BC is our unchanging goal, to which we are gradually approaching with your help. The meeting is like our guiding star, and with it we will never get lost.

Your timely decision to issue us the coal license is a great help. Not only provide the legal basis and guarantee for us to achieving our goals, which make our work more efficient, but also shorten our proposed timelines.

It means a lot to us and I don't know how to express my feelings, and it is the main reason that made me write this letter to you.

I sincerely invite you and your staff in Ministry of Energy, Mines and Petroleum to visit China, and I am willing to pay the fees associated with the trip, including roundtrip air tickets, food and accommodations costs.

- Woodjam – calcalkaline porphyry
- QR – wrong colour to match legend
- Greenwood – wrong colour to match legend
- Merry Widow and Tasu – wrong colour to match legend
- Sustut – right colour, wrong symbol should be volcanic redbed copper
- Harper Creek – calcalkaline porphyry
- Katie – alkaline porphyry
- Greens Creek Alaska doesn't have copper

Small points:

1. moved symbol for past producer into legend box with deposit types
2. how about ~ 9 Mt of historic copper production from 440 producers
3. with ~ 25 Mt of copper resources reported from 185 deposits (statistics from BC MINFILE)
