### **Highlights & Issues**

**Davidson** open house/ public meeting attended over 180 people. Presentations by Ken Collison (Blue Pearl), Roger Tailleur (EAO), Shane Uren (Rescan). Opposition to the project was more evident by questions than at earlier public meeting. A draft of the Terms of Reference for the project will be open to public review in November.

**Trespass access trail** - DWF and AJP accompanied Conservation Officer on aerial reconnaissance of a 21 km non-permitted access trail that originates from placer access on Little Dease Creek, north of Dease Lake. Complaint originated from MoF, purpose of trail unknown, investigation anticipated.

Tahltan-EA Workshop - Planning for Oct 22-25 event in Dease, Iskut and Telegraph - this will be a major event.

**Gateway -** Enbridge's proposed \$2.1 billion double pipeline project, crude oil export and condensate import between Edmonton and Kitimat (or Prince Rupert). To carry 400,000 bpd of oil-sands oil in 30 inch pipe and 150,000 bpd of condensate in 16 inch pipe. Field studies in progress 2005, targeted construction period 2008-2010. Met with AMEC consultant working on impacts on mining industry (eg workforce, contract/equipment availability, highway truck traffic). Open house in Smithers, Oct 28, Native Friendship Centre.

**Urgent outstanding Issues** - Red Chris permit, Contracts for Turnagain reclamation and RG help, office space, hiring new staffing.

Galore - Project Report anticipated Feb 2006. Proposed mill rate is now 65,000 tpd.

#### Gentlemen:

We are awaiting final word from Thompson Creek regarding their interest in Unity. Endako has completed their technical review and has submitted it to their Denver office for marketing, financing and executive review. We expect to hear back the end of the first week in June.

Imperial Metals have expressed an interest in a Unity ore backhaul to Huckleberry. However, they are busy working on a new ten year plan with consideration of lower than expected metal prices, for the Japanese financiers. This activity is nearly all consuming for Imperial management at this time. Hence, they have allowed me to approach Arrow directly regarding the backhaul and we expect to be able to sit down with Imperial in early June to review the Huckleberry onsite process capacity for the moly circuit.

If these discussions fail we still intend to attempt a small financing and then push forward with a feasibility and permitting for a stand alone operation, subject to there being some certainty that there is a direct fast-track line to permits.

I will keep you informed of any new developments as they occur.

Eskay Creek plans to produce 95,000 tonnes of direct shipping ore and 60,000 tonnes of milling ore this year.

Metal production is estimated at 291,950 oz of gold and 10,756,000 oz of silver. The company is considering expansion of the mill. This would lower production cost and enable mining of lower grade ore, such as 21C zone.

21C is to be evaluated by a bulk sample and detailed drilling from underground development now in progress.

**Yorke-Hardy** moly deposit (Hudson Bay Mtn)- Development as a <u>high grading operation</u> being considered by Verdstone and Molycor, by direct shipping to Endako at a proposed 2,000 tons per day.

Endako milled ore from the low-grade stockpile during December and January, supplementing pit ore and lowering production cost. Milling is about 70% pit ore and 30% stockpile. Stockpile grade is better than expected and averages about 0.057% Mo. Recovery is also better than expected.

Trimetals Resources propose to drill the Owl Lake moly showing northwest of Endako.
