Director

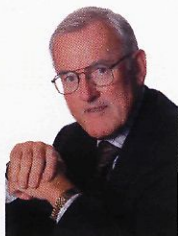

Director

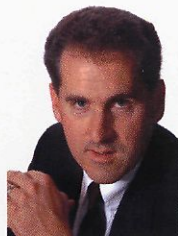
