Re: Your FAX of Oct. 15, 1998 - Gibraltar Mine Data

Tom - A few highlights as requested. (So far has been an interesting year)

- Reported ore reserves as of Dec. 31,1997
 Mill 184,384,000 tons @ 0.310 Cu and 0.010 Mo
 Leach 16,321,000 tons @ 0.206 Total Cu and 0.151 Acid Soluble Cu
- Jan 1998 Boliden takes over Westmin (Gibraltar Mine).
- Mar.1998 Boliden announces Gibraltar Mine will be shut down in Dec. 1998. Gibraltar East Pit ore mined out by Dec. 1998, rock stripping in Pollyanna Pit shut down in Mar 1998 but overburden stripping continues - overburden used for dump reclamation - no layoffs till Feb. 1999.
- April 1998 GM claims exploration (1 km north of Pollyanna Pit) 5 diamond drill holes drilled on strong geochemical and IP geophysical anomalies. Mineralization encountered in 4 drill holes - good Mo (Ave. ~0.030% MoS₂) and fair to good Cu (0.15 to 0.2% TCu in primary zone and >/=0.30% TCu in supergene enriched zone) - more work required.
- June 1998 Gibraltar agrees to cooperate with United Gunn Resources Ltd. (They have an interest in Gibraltar through Cuisson Lake Mines Ltd.). United Gunn doing exploration on several claim blocks adjacent to the Gibraltar Property.
- July 1998 Gibraltar reports ~ \$3 million profit for the first half of 1998 (related to low Canadian \$, lower smelter costs, cost cuts at the Mine, etc.)
- Sept. 1998 Boliden agrees to allow Gibraltar management to proceed with a restructuring plan. Gibraltar to become an independent company (Boliden will retain 10% interest). A letter of intent was issued with several conditions to be met by Dec.18, 1998. Pollyanna rock stripping started again in Oct.

• If restructuring is successful, expect to continue mining operations. Also expect to continue exploration - in particular, begin diamond drilling on the Gibraltar West Extension zone (previously called Gibraltar North) in 1999 (subject to an acceptable agreement with Oakmont Ventures Ltd.). United Gunn also plans to drill several IP anomalies on their claims in 1999.
