Gentlemen,

Phil's Diamond Drilling Ltd. of 100 Mile House is preparing to mobilize a Longyear 38 and a dozer to the Goldstream site toward the middle of this week in anticipation of the Orphan Boy financing being completed late this week. Craig Payne, President, Crest Geological and Phil Lindenback, President, Phil's Drilling are coordinating the mobilization to site and the drilling with Red Daley, Imperial's Goldstream Mine Caretaker. The government Notice of Work Approval is in hand which allows drilling to commence now. If we hit on the first round of drilling at the target just east of the Goldstream mill we will continue drilling through the winter as the target is at a low elevation in the Valley and very close to plowed logging roads. The first target we plan to drill has the potential to be a "home run" because of its one kilometre diameter coincident EM and metals-in-soils anomalies and its proximity to the Goldstream deposit (1.5 km east).

EXPLORATION HIGHLIGHTS:

Tungsten - the recent rise in prices (to about \$7/Kg for WO₃) has prompted North American Tungsten to re-open it's CanTung mine in NWT. The mine hosts high-grade tungsten skarn reserves (grading approx 1.8% WO₃) but has been on care and maintenance since 1986 due to low prices caused by Chinese dumping. NAT has signed a sales agreement with Sandvik and Osram Sylvania to supply tungsten for three years. CanTung will become the largest producer in the world and will be the only mine in North America. Recent tungsten skarn discoveries in southern BC may begin attracting exploration attention in the near future (e.g. Dave Ridley's Fox and Camille Berube's Lucky Bear claims). Numerous other historic tungsten prospects are open for staking and may also receive some attention.

Red Hill (Teck Corp) - 15 holes have been drilled so far (out of possible 20 holes and 4000 m) on this VMS Cu-Zn target near Ashcroft. First Nations people were holding a "bitterroot festival" on the property this week. A large group was collecting bitterroot for use as a medicinal herb, but they were friendly and were not upset by the drilling activity.

Goldstream (Orphan Boy Resources) - financing of \$750K complete but awaiting final paperwork; another \$1.3M is being negotiated. Expect drilling of 1000 m near the Goldstream mine by late June.

Ledge (Manadabay Resource Corp) - Approx 500 m drilled on this property east of 100 Mile, apparently without the agreement of the claimowner Dave Ridley who has not received a property payment!

Siwash (Int'l Tower Hill Mines Ltd) - 5 ddh planned to test this Au-Ag-Cu prospect near Brenda mine.

Pongo (Molycor/Verdstone) - small trenching program underway on this high-grade Au-Ag-Pb-Zn-Cu vein/shear zone prospect near East Barriere L. Molycor also raised ~~\$75K~~ *change*

Other Financings - several companies have announced small financings to complete summer work and/or keep the lights on e.g. Jaguar Int. (\$225K total) and GWR Resources (\$188K).

Highlights:

Goldstream (Orphan Boy Resources) - Drilling of 6 holes (900 m) and geochemical and geophysical surveys are underway on this property north of Revelstoke. The main target areas are a geophysical anomaly 2-3 km east of the mine, and the C-1 area about 10 km west of the mine. Both areas have coincident Cu-Zn-Pb soil geochemistry and cover the Goldstream mine horizon. The mill, tailings pond, and mine camp are all reported to be in good condition, ready to be started up if new ore can be located. Total budget for the work this year is about \$300,000. (Visited on 9/26 with Craig Payne, consulting geologist).

Melba (Walloper Gold Resources Ltd.) - Trenching has exposed a 30 m long, 3-5 m wide zone of chalcedonic quartz breccia on this property located about 30 km southwest of Kamloops. Diamond saw channel sampling on 2 m line spacing is currently underway. Anomalous gold and arsenic values from previous float sampling helps to confirm an epithermal model for the mineralization. Other nearby "mesothermal" quartz veins have also returned anomalous gold values. Drilling of 500 m is planned for early October. (Visited on 9/28 with R. Adams, L. Saleken (Pres.), W. Botel, and G. Crooker).

Getty South (Getty Copper Corp.) - Getty is looking into the possibility of drilling a few reverse circulation holes this fall.

HIGHLIGHTS:

KEG/MEM Workshop on "Exploring the Map Place" - On Sept 21, two four hour seminars were taught by Larry Jones, Don McIntyre and Pat Desjardins of the GSB. About 19 people were in attendance for this useful, well presented course. Thanks to the GSB and Larry, Don and Pat.

Goldstream (Orphan Boy Resources) - approx. ³²⁰\$300K program of ground surveys and drilling has just begun on this large property north of Revelstoke. Stratiform Cu-Zn-Pb mineralization is the target.

Minister Hagen - Assisted Penny Foster (Williams Lake Mining Committee) pull together facts and suggestions on how to improve the BC investment climate, for her meeting with Minister Hagen of MSRM.

Field Visits:

Mt Fleet (Adam Travis/Santoy Resources) - visited this new syenite-hosted platinum-palladium-copper prospect northeast of Kamloops on Sept 18. Up to 0.95 g/t Pt has been returned from copper-stained syenite. We also visited the nearby **Shaw Hill** Cu-Au prospect to the east where Travis has now staked 6 units. Strong albite-biotite and carbonate alteration, disseminated and fracture-controlled chalcopyrite-pyrrhotite mineralization, and (unmapped) diorite-gabbro intrusions combine to suggest a brand new alkalic porphyry Cu-Au prospect may be developing. **CONFIDENTIAL**

Exploration Activity:

Afton (DRC Resources Corp) - Reported intersection of 43 feet grading 2.05% Cu, 0.028 opt Au and 0.206 opt Ag. Depth of 874 metres may be prohibitive for mining!

Various - Assisted several independent and company geologists to acquire data or maps for potential property acquisitions. Some talk that things might be picking up with the improvement in the price of gold and companies returning home from more dangerous locations overseas (e.g. Africa, central Asia)

New Discovery At Goldstream Joint Venture Property

Prospecting a coincident copper, zinc and silver soil geochemical anomaly some 600m long and 75m wide within the C1 area of the Goldstream River valley has discovered angular massive sulphide boulders up to one metre in size. The massive sulphide consists of pyrrhotite, trace chalcopyrite, sphalerite and galena enclosing coarse subrounded quartz, carbonate and host rock inclusions, a texture described as "durchbewegung" fabric. A similar fabric is observed in the massive sulphide zone at the nearby Goldstream Mine. Geochemical results of the massive sulphide material yielded up to 1553ppm copper. Structurally overlying the massive sulphide boulders at the discovery are outcrops of "Garnet Horizon" a manganiferous, spessartine garnet bearing and iron rich (gruenerite) cherty unit. This unit also structurally overlies the Goldstream massive sulphide zone. This new showing is referred to as the Boutwell discovery.

The discovery of massive sulphide boulders and Garnet Horizon in outcrop at the Boutwell showing, located some 10km west of Goldstream Mine, has opened up a significant amount of stratigraphy between Goldstream and the C1 area with the potential to host more Goldstream, Beshi type massive sulphide deposits.

HIGHLIGHTS

* **Goldstream (Orphan Boy Resources Inc.)** - reported that angular massive sulphide boulders up to 1 m across have been found at the **Boutwell Discovery** in the C-1 grid area, some 10 km west of the Goldstream mine. The prospect occurs within a 600 m long Cu-Zn-Ag anomaly. The massive sulphides are comprised of pyrrhotite with minor chalcopyrite, sphalerite and galena, have a "durchbewegung" texture similar to Goldstream, and are interpreted to occur at about the same stratigraphic position (near the "garnet horizon"). Assays show the boulders are anomalous in copper (to 1553 ppm Cu). The prospect is at a low elevation in the Goldstream valley and should be the focus of further trenching and drilling in 2002.

* **Spire (Imperial Metals Corp)** - no official news release has come out, but the Imperial Metals website includes an Adobe presentation with photos, maps and results from their recent trenching program. The best result was a channel sample in a new trench which graded 3.4% Cu and 2.9% Zn over 1 m. The prospect also has similar geology and ore textures to the Goldstream mine, 7 km NE. Thi Goldstream area north of Revelstoke could be busy in 2002.

EXPLORATION NEWS

* **Duke Copper (MF92ISW076)** - Southern Rio Resources acquired this copper prospect located 20 km west of Craigmont in the Guichon Creek batholith. Drilling of 12 holes in the 1960's returned up to 0.63% Cu over 57.9 m. Southern Rio is returning to BC from Chile to take advantage of the flow through tax credit, according to Lindsay Bottomer (former President of BC and Yukon Chamber of Mines and Exploration Manager for Echo Bay).

* **ED Property** - Lyra Resources has optioned an 82 unit claim group adjacent to their ED 1-20 block, located near Edith Lake south of Kamloops.

OTHER:

Merritt Area till paper - wrote up and submitted a short section on Regional Geology and Metallogeny for a paper on surficial geology in the Merritt area, to be published by Bobrowsky et al. in *Geological Fieldwork, 2001*.

Exploration Review Talk - continued preparation of graphics and speaking notes for presentation in Victoria on Nov. 22.

Subject: Possible Discovery at Goldstream C1 Zone on Joint Venture Mineral Lands

Gentlemen,

You are the first to be informed outside ORS that Craig Payne and his team at Goldstream may be on the "verge" of a discovery on the C1 Zone at Goldstream. Craig called me at Noon today to say that they have found several desk size angular boulders that look just like Goldstream ore. They have not been able to locate the source due to overburden thickness (tried unsuccessfully to dig through to subcrop with picks and shovels). They have however found an outcrop of the garnet horizon within a couple of hundred meters of the high-grade float. Gordon Gibson is working with Craig on this discovery.

The discovery location is 50 meters northwest of the C1 baseline on Line 70W and Line 69W in heavy timber on a steep southeast slope. The discovery is in a geochemically anomalous zone as defined by Goldnev, and 175 meters south of the "projected" Mine Horizon outline as plotted by Goldnev. The nearest road access is 500 meters from DDH C-15 which is due north of the discovery. However, in creating access for drilling in 2002 we will consider building a road from the Mine Road at Line 55W at +15% incline for 1.5 kilometers southwest to the discovery. This new road would parallel (100m to 200m south) the Mine Horizon, as now plotted, and pass through very favourable geophysical and geochemical anomalies defined by Goldnev in the early 1990's.

Rainbow

HIGHLIGHTS:

Afton Area (Abacus Mining and Exploration Corp) - closed \$550K financing which will be spent on the seven properties optioned from Teck Cominco et al. The main focus will be the Rainbow property which hosts the Rainbow #2 and #17 zones. Both are breccia-hosted, alkalic porphyry Cu-Au deposits. Previous work by Teck indicated locally enriched palladium values in the Rainbow deposits (e.g. hole 95-22 hit 33 m grading 0.74% Cu, 0.18 g/t Au and 0.62 g/t Pd).

IMS

Kettle Valley Stone Co. - Demand appears strong and sales are growing again after a sharp post-Sept 11 slowdown. Product for several large projects in California was being manufactured at the time of our visit on 1/28. Unfortunately the company is suffering from cash flow problems and new investors are being urgently sought. KVS sold approx \$1.6 million in product in 2001 and recently bought a 36" circular saw (\$110K) to cut large blocks. Several new products are being test marketed, including "tumbled pavers" of dacite and basalt.

Hinker

Okanagan Opal Inc. - Madu and Cathro visited the Vernon shop and borrowed specimens for display at the BC booth at PDAC. Owner Bob Yorke-Hardy indicates that their business is just now starting to pick up again after their Sept. 2000 move from their previous location, which was expropriated by MoTH for a highway interchange.

Tulameen (Bright Star Ventures) - expanded land position with acquisition of 48-unit J&L property on Olivine Mountain.

Big Bend Project (Orphan Boy Resources Inc.) - Notices of Work received for drilling on several copper-zinc-lead-gold-silver massive sulphide targets north of Revelstoke. EXPLORATION AND MINING NEWS

Mac Claims (aka "Top", MF 082LSE017) - This gold-silver prospect, owned by Linda Caron and John Kemp, has been optioned by Cantech Ventures Inc. Drilling by junior companies in 1983-88 intersected up to 13 metres grading 16.1 g/t Au in a faulted vein. Commonwealth Gold Corp drove a 126.5 m decline in 1990, and the mineralized zone is reported to have averaged 14.4 g/t Au over 10 m. The company plans to hire a structural geologist to find the faulted extension of the vein.

Zeo (Zeo-Tech Enviro Corp./C2C Zeolite Corp) - Zeo-Tech has shipped its first container (20 tonnes?) of Princeton zeolite to Taiwan for use in the aquaculture industry. The company reports that their zeolite increases production of farmed shrimp.

Panorama Ridge (Goldcliff Resource Corp) - trenching and geochem have begun on this Hedley-area gold prospect. Follow-up drilling will depend on financing.
