## Harvey Creek Property

Kinbasket Lake Area, Southeast BC

### Summary

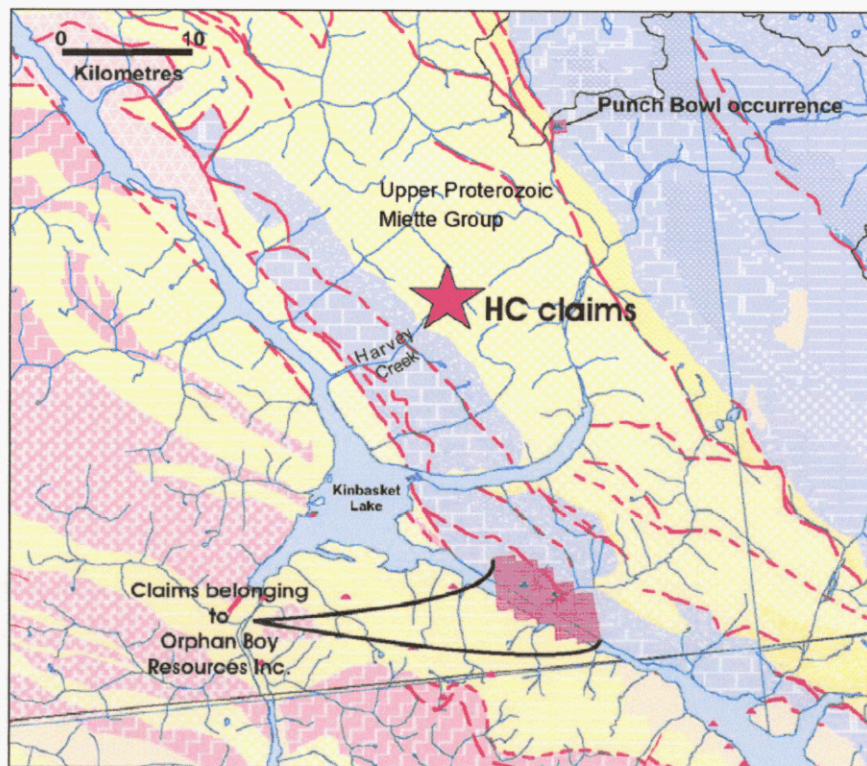
The Harvey Creek property is an exciting new prospect that may have significant potential for gold. In the early 1960s, internal Falconbridge exploration reports described a 2 mile long structure, 10 to 50 feet wide, containing quartz veins and up to 0.3% copper; no mention is made of gold analyses. Falconbridge was conducting regional exploration in the area in 1961 and 1962. The showing was described as a "schist belt that contains much disseminated sulphide and locally considerable vein material. The zone is mineralized with chalcopyrite, pyrrhotite, pyrite and quartz".

### Claims, Location and Access

The Harvey Creek property claims are approximately 142 kilometres north-northwest of the town of Golden on NTS map sheet 083D08W or TRIM map 083D029. The claims were staked in early 2006 and total about 791 hectares and are 100% owned by Garry Payie, the property vendor. The claims are in the Golden Mining Division, Tenure Numbers 525305 and 529225.

### Geology and Mineralization

The Harvey Creek prospect is just east of the Rocky Mountain Trench and has some similarities to the Punch Bowl showing (MINFILE 083D 038) located 15 kilometres northeast. Assays from the Punch Bowl ranged up to 26 grams per tonne gold. Gold-quartz mineralization at the Punch Bowl is contained in a series of discrete vein structures confined to quartzites and lesser pelites of the McNaughton Formation. Over 20 veins have produced anomalous gold values; although distribution of gold within individual veins is highly erratic. Visible gold has been observed.

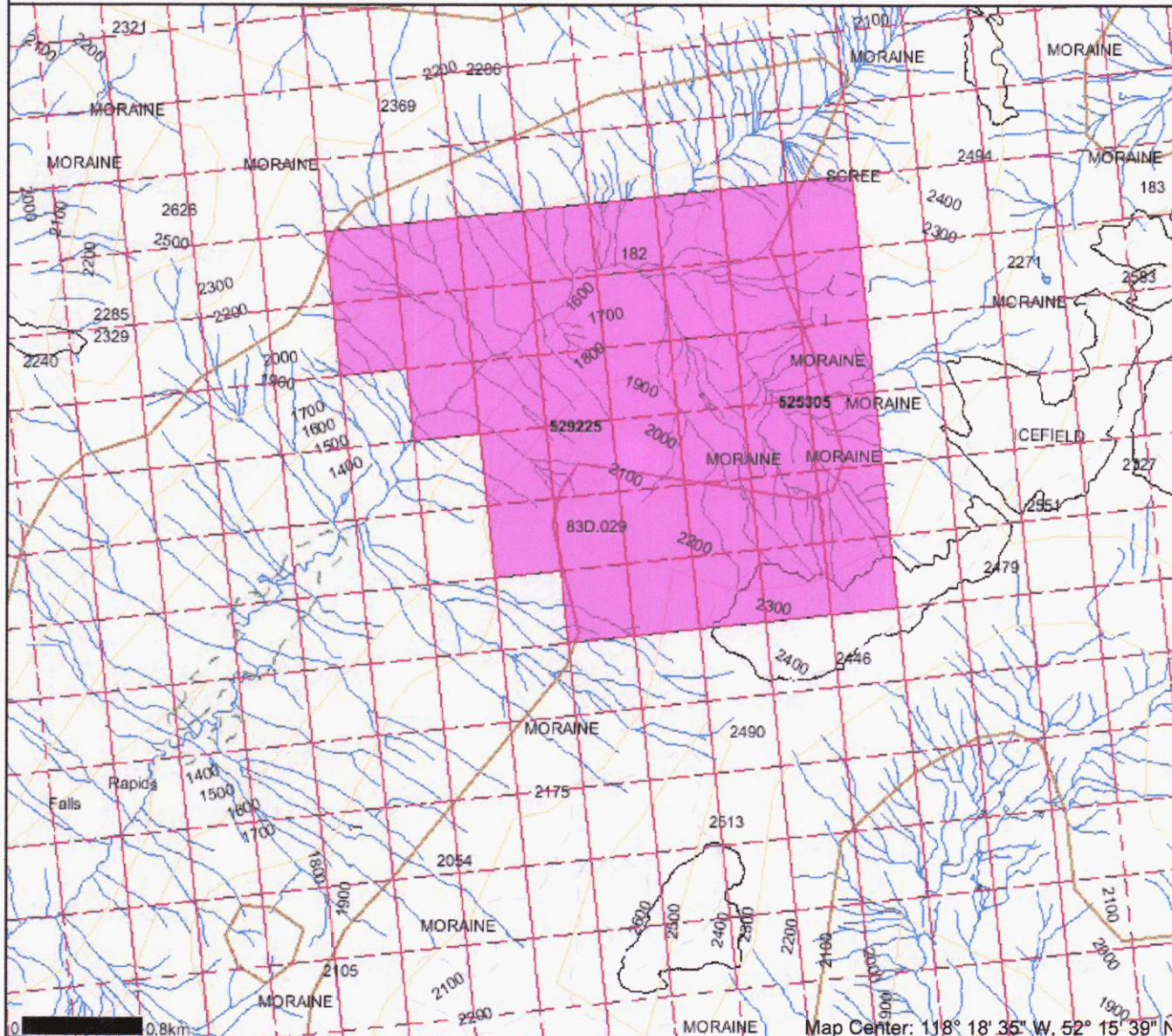
