## The Hen Property


The Company advanced the Hen gold skarn property with results including 35.04 g/t gold in a grab sample and a chip sample returned 3.5 metres containing 3.46 g/t gold that remain open. Nicola Group calcareous volcanic sediments, marble and basic flows are in contact with granodiorite-diorite, and strong biotite hornfels, calc silicatepyroxene, carbonate, and locally k-feldspar alteration are spatially associated with pyrrhotite, arsenopyrite, and gold.

### The Art-DL Property

The Art-DL gold property (Minfile 093A 200, 089) is underlain by Middle-Upper Triassic Lemieux Creek succession in proximity with the Eureka Thrust that divides Quesnel Terrane from older Snowshoe rocks to the east. Black phyllite cut by pale felsic dikes contain quartz veins with pyrite, trace galena, chalcopyrite and tetrahedrite and up to 42.9 g/t gold over 1.0 metre at the DL adit and grab samples of 1.22 g/t gold, 620 ppm silver occurs. The property appears to have in part a similar geological setting as the Spanish Mountain prospect near Likely, B.C.

## The Hawk Property

The Hawk (Minfile Clay 092P155) copper-gold-silver property is located on the contact between diorite, monzodiorite and chloriteepidote altered Nicola Group volcanic rocks. Marble up to 5 metres in

thickness can be traced intermittently over 1 kilometre. Structure and in part lithology control pyroxene skarn and together with pink calcite veins contain dominantly bornite and copper oxide minerals. Historical drilling returned 0.61 metres containing 2.0% copper, 28.0 g/t silver, 6.13 g/t gold in drill core, and 100 metres south, 5 metres of 0.88% copper, 1.07 g/t gold occurs in outcrop at the main showing, and a further 600 metres south, 0.25 m contains 2.17% copper, 15.0 g/t silver and up to 8700 ppb (8.7 g/t) gold.
