Subject: Lane Weekly Report for NE-Central BC to November 7, 2003

Mineral Exploration News for NE-Central BC to November 7, 2003:

Mount Polley. Imperial Metals has released more impressive assays on its completed 3221 m, 16-hole phase 1 drill program on the Northeast zone. Hole WB03-15, the furthest hole to the SE, intersected 135 m averaging 1.16% Cu & 0.35 gpt Au. The zone has a minimum strike length of 275 m in a NW direction, but its width is unknown. Plans for phase 2 are being developed.

The first hole completed on the Springer zone, drilled to test beneath the current pit design, intersected 466.3 m grading 0.49% Cu and 0.36 gpt Au. The bottom 267.5 m of the interval is below the pit design and averaged 0.61% Cu and 0.49 gpt Au. Imperial has recently raised \$10 million for exploration, the bulk of which will go toward further work at Mount Polley. With early success at both the Northeast and Springer zones, the company will likely have two drills turning on the property in the near future.

Gibraltar. Masoko Mines has begun a third phase of drilling on the mine site east of the Pollyanna pit. The focus of the exploration program is the 98 Oxide zone, where the company is intent on developing sufficient tonnage to support the resumption of its SX-EW plant.

Cariboo (Most Likely), Cantin Creek and QR. Cross Lake Minerals and JV partner Gold Giant Minerals have initiated a 6-hole diamond drilling program on the Cariboo epithermal gold property located immediately east of the QR mine. Two holes are planned for the Cantin Creek epithermal gold prospect and a series of holes will be drilled at QR to further evaluate near surface skarn/propylite mineralization.

Nina. Dave Haywood and Gary Lee have mobbed into their Nina VMS property north of Germansen Landing to investigate (drill and blast) a coincident VLF-mag-Cu anomaly.

Star. Minterra Resource Corp. has optioned the Star property, centred 13 km NE of Aiken Lake in the Lay Range, from Ursala Mowat. The company is proceeding with an 8 line-km IP survey asap that will assist in the identification of drill targets. Mineralization consists PGE-bearing cpy and po within olivine clinopyroxenites and pyroxenites of the Polaris Ultramafic Complex.

3Ts. Southern Rio Resources is energized to initiate an approx. 20 hole diamond drilling program focused on establishing a resource for the Ted vein.

Laidman and Holy Cross. Bard Ventures is proceeding with small 3D Inversion IP surveys on the Laidman and Holy Cross epithermal gold prospects, located in the Nechako Plateau.

Bonanza Ledge. International Wayside Gold Mines Ltd. was forced to temporarily abandon development of its decline (by DFO order) and focus entirely on sediment & erosion control issues with respect to its upgrading of the Scouts Gulch road, the proposed haul route for the Bonanza Ledge bulk sample. Shut down resulted in the loss of 4-5 days of underground development.

Nuggett/Cunningham Creek. Consolidated Pacific Bay Minerals completed a trenching and sampling program on its Cunningham Creek area property in search for high grade gold veins and replacement zones.

Lane Weekly Report to December 6, 2002

Northeast-Central Region

Exploration Update

Cariboo Gold Quartz (International Wayside Gold Mines Ltd.)

International Wayside announced resource estimates for the Bonanza Ledge and BC Vein zones on its Cariboo Gold Quartz property near Wells. The indicated resource for Bonanza Ledge is 337,500 tonnes grading 8.12 gpt Au and the indicated resource for the BC Vein is 296,000 tonnes grading 5.31 gpt Au. In both cases a cut-off grade of 0.7 gpt Au (0.02 ounces/ton) was used. Existing open pit resources for the Cow Mountain (Sanders-Pinkerton-Rainbow zones) total about 6.014 million tonnes averaging 2.23 gpt Au. A revised mine plan that takes these new resources into account will be presented in Wells on December 11th.

Wolverine and Burnt River (Western Canadian Coal Corp.)

Western Canadian Coal Corp. has raised approximately \$900,000 for work on its stable of coal properties in the Peace River Coal Fields

Laidman, Holy Cross and Clisbako (Bard Ventures Ltd.)

Bard Ventures has optioned three gold projects, Laidman, Holy Cross and Clisbako, from Geoff Goodall. All three lie in the Nechako Plateau area of central BC and have received very modest levels of exploration in the past. Under the agreement Bard will expend \$100,000 per property over the next two years.

Fran (Navasota Resources Ltd.)

Navasota Resources has surprisingly dropped its option on the Fran property, host to a high-level porphyry gold-copper system, near Inzana Lake. Navasota drilled 27 holes totaling 4105 metres this year.

Issues:

D&G Placer Mining: challenging BC. Gov't, inspector and reclamation contractor's authority to dispose of an old trommel through a filing of a Writ of Summons and Statement of Claim in the Supreme Court of B.C. Briefing Note being prepared.

FYI:

Cariboo Gold Quartz - Bonanza Ledge. International Wayside Gold Mines reports encouraging assays results from holes BC01-15, BC01-17 and BC01-18 drilled on the Bonanza Ledge zone. The intersections extend the strike length of the 'replacement-style' mineralization to over 1000 meters. The highest-grade mineralization encountered was a 13.2 m intersection in hole BC01-15 that averaged 5.97 g/t Au. Drilling is about to begin testing a large anomaly beneath the Bonanza Ledge zone. An IP survey is underway.

Kemess North. Northgate Exploration Ltd. has released a revised resource estimate for its Kemess North deposit based on data contributed by the 2001 diamond-drilling program. The Inferred Mineral Resource is 442 million tonnes grading 0.4 g/t Au and 0.23% Cu (at a cut-off grade of 0.6 g/t Au equivalent). The most significant intersections from the second phase of drilling include: 111.3 meters grading 0.60 g/t Au and 0.25% Cu in hole KN-01-12 and 210.9 meters grading 0.49 g/t Au and 0.30% Cu in hole KN-01-13. The second phase of 2001 drilling also confirmed the existence of a north-trending fault (East Creek fault) that truncates the Kemess North system to the east. The offset portion of Kemess North may be the Kemess East anomaly, located 600 meters to the SE. An expanded drill program is planned for 2002.

Hixon Creek Placer. Operator LeWayne Musselwhite continuing to work on a placer gold channel near the former Quesnel Quartz gold mine. McGrath/Lane mapped face on either side of portal and sampled vein material.

Fran. Drilling continues at this property located 70 km northeast of Fort St. James. Grab samples graded more than 40 g/t Au.

Holy Cross and Laidman Lake. A limited prospecting program, located in the Nechako Plateau area south of Vanderhoof, has located high grade gold-silver mineralization. The highest assay was 24.2 g/t Au and 20.8 g/t Ag. Brief prospecting at the nearby Laidman Lake property, resulted in a sample that assayed was 4.7 g/t Au with 10 g/t Ag. Further exploration planned for next year.
