HIGHLIGHTS:

Afton Area (Abacus Mining and Exploration Corp) - closed \$550K financing which will be spent on the seven preperties optioned from Teck Cominco et al. The main focus will be the Rainbow property which hosts the Rainbow #2 and #17 zones. Both are breccia-hosted, alkalic porphyry Cu-Au deposits. Previous work by Teck indicated locally enriched palladium values in the Rainbow deposits (e.g. hole 95-22 hit 33 m grading 0.74% Cu, 0.18 g/t Au and 0.62 g/t Pd).

Kettle Valley Stone Co. - Demand appears strong and sales are growing again after a sharp post-Sept 11 slowdown. Product for several large projects in California was being manufactured at the time of our visit on 1/28. Unfortunately the company is suffering from cash flow problems and new investors are being urgently sought. KVS sold approx \$1.6 million in product in 2001 and recently bought a 36" circular saw (\$110K) to cut large blocks. Several new products are being test marketed, including "tumbled pavers" of dacite and basalt.

Hi Tom:

I think the time related to having to relocate our business during our peak season cause a few frayed synapses. We had to re-print all our brochures and did not get the new ones distributed to everyone. One way to post something would be to print off the digging page (and or other pages) from our website at <www.opalscanada.com> We will send some brochures.

Our website has been updated showing our new shop at which we, in addition to trying to develop a market for BC Opal, act as "tourist guides" giving an overview of our project, the mining industry and the Okanagan (BC) in general. We have not been able to get assistance from the Ministry of Tourism regarding a Highway sign --- they consider us as a "retail store".

The "forced" move came at a very difficult time; and as it turns out inappropriate time as well. It appears that the project scheduled for a September 1, 2000 start will not start for three+ years. The Highway's Department stated that they would make us whole but this has not yet happened. They too are treating us as a "retail store" when considering "impacts" on our business. We wonder how many (w)holes they are try to make of (in) us. Our costs are double at this new location and we do not have ownership (lease with option) of the new site.

Further, our application for 20% tax credit for our 1998 (and subsequent) exploration has been held up by Revenue Canada (CCRA) who say that we are in production not exploration. This is a direct loss of \$35,000 to \$40,000 to us for 1998 and 1999. We have tried to get help from the BC MEM but so far nobody wants to "get involved" in helping to explain what we have done by examining the work and providing advise. This ruling would also negatively affect all of our "flowthrough share investors".

Further, Revenue Canada has re-assessed my personal tax credit application. They also have assessed me for personal use of our company vehicle because I cannot prove that it was used over 90% for business.

Further, our Okanagan Opal Inc. financial statements have been audited. The CCRA has assessed GST on Option Payments received in 1996 and want \$28,000 plus penalties mounting to about \$10,000. <u>NOBODY PAYS GST ON OPTION PAYMENTS.</u>

In the meantime, as for mineral development, we are trying to put together what we believe can be a substantial industry in the Okanagan and throughout BC (since other opal deposits have been located). The red tape and speed bumps seem destined to delay this. We have proven a sufficient reserve of commercial grade opal at our deposit to support commercial production but cannot interest anyone in helping to develop it. CHEERS, Bob
