**Achievements in 2000**

G W R Resources Inc. has continued to explore its' 100% owned Ann property near Lac LaHache, B. C. Diamond drilling in the Ann North zone has located a favorable host containing potentially economic copper-gold values, and provided the geological framework to suggest excellent potential for a large copper-gold resource to occur.

Thirteen diamond drill holes, totaling 2,621.3 meters (8,600 feet), were completed on the Ann North Zone between mid-May to mid-November, 2000. A strong regional and property-scale magnetic low with a diameter of approximately 1 km is centered on the area of interest. Low to moderate induced polarization chargeability effect occurs to the south and east. Widespread, weak to moderately anomalous copper and gold concentration in soil occur where overburden is 3 to 40 meters in thickness.

The geology, alteration and mineralization in all of the drillholes, in addition to the overall size of the favorable geophysical and geochemical expression, suggests excellent potential to expand the zone, and for the development of a large porphyry copper-gold deposit.

**Goals for 2001**

- ◆ continue to enhance the integrity of the Company by sound board and management decisions
- ◆ introduce the Company to a wider scope of investors and analysts
- ◆ expand the drill program on the Ann claims
- ◆ commence an aggressive drill program on the recently acquired Tam claims to follow up previous drill program that have had excellent assay results.

**The Company**

G W R Resources Inc. is a Canadian exploration company focused on the development of its Lac LaHache copper-gold porphyry project located in south central British Columbia. G W R was incorporated in February, 1987 under the Company Act of British Columbia. The Company has been listed on the Canadian Venture Exchange (CDNX) since June, 1988 under the symbol GWQ.

G W R holds various interests in several contiguous gold-copper mineral claim groups known as the Lac LaHache Project. The Lac LaHache Project is comprised of seven different property groups covering more than 25 square kilometres in south central British Columbia. The most recent acquisition of an undivided 80% interest in 35 mineral claims (the "Tam" claims), which are adjacent to the Company's Ann Property and approximately 2.0 kilometres from the Ann North Zone (see the Company's news release dated January 15, 2001). These claims were acquired due to their proximity to the Ann North Zone.

To date, a total of \$ 7 million has been spent on exploration of the Lac LaHache Project by various companies. Currently there are a number of senior and junior mining companies active in the Lac LaHache area including Boliden Westmin and Imperial Metals.

The Ann claims, which the Company is currently exploring, are underlain by the rocks of the Upper Triassic and Lower Jurassic Nicola Group volcanic-arc sequence which have been intruded by dioretic to syenitic rocks of similar age. Throughout British Columbia the Nicola Group sequence of volcanic and related intrusions have been responsible for several significant copper-gold deposits, most notably Copper Mountain, Afton/Ajax, Mount Polly and Mount Miligan.

David Blann, P.Eng., the Company's geologist since 1992 and Chris Wild, P.Eng, former Chief Geologist at Imperial Metal's Mount Poley Mine, are directing the Company's 2000 and 2001 drill program.

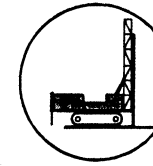
