## NEWS RELEASE

MASTT RESOURCES INC. is pleased to release the following information.

GEOLOGY: Exploration Hole #1, Middle Paleozoic rock formation with milky quartz and rich disseminated sulphides for 30 meters. DH#1 with a(depth 260'), encounted 155' of black argillite, quartz veining and disseminated sulphide mineralization. DH#2 (depth 325') DH#3 (depth 260'), & DH#5 (depth 505'). These drill holes encountered from 180' to 305' intense alteration, rich disseminated sulphide mineralization, fracturing and local veining. DH#4 (depth 345") intersected volcanic and clastic rocks with disseminated sulphide mineralization to a depth of 105", 85' to 105' abundant sulphides, 105' to 115' syenite, 105' to 265' rocks are fractured, contain abundant sulphides and locally are veined with quartz. DH#9 (depth 505') from surface to 80' highly altered volcanic and clastic rocks, from 80' to 105' appreciable sulphides, 105' to 345' abundant disseminated sulphides in fractured rocks crosscut with chalcedonic quartz andcarbonate stockwork veining. VISIBLE GOLD was observed in six ten-foot intervals covering a range in excess of 200 feet. DH#10 (depth 305') also in pit area. VISIBLE GOLD in a ten-foot intersection. DH#11 (depth 210') testing for "QR" type mineralization peripheral.
