Progress to note regarding the 1988 field trip is as follows:



Dear Don:

Thank you for your letter of March 3 about the 1988 SEG field trip. I am heading for the field soon and I would like to review the 2 areas in which I have made some progress.

- 1. I did get to Cinola on the Queen Charlotte Islands in early March, despite a most unusual, raging snow storm. I got a good look at the logistic requirements for a field trip. My journey has reaffirmed my conviction that only the three major N.W. B.C. precious metal deposits are feasible within a normal SEG style excursion. Bralorne is simply too far away to be included. What I propose is a 4 to 5 day trip starting in Vancouver and ending in Smithers with visits to Cinola, Stewart (Silbak Premier) and Equity Silver. The tour will include scheduled airline travel between Vancouver and the Queen Charlottes, chartered aircraft between the Charlottes and Prince Rupert and bus transport to Stewart and Equity.
- 2. The field trip committee has now expanded by 100% to include Tom Schroeter, our Vancouver-based Senior Regional Geologist. Although they don't know it yet, I plan to inveigle our Smithers District Geologist Dave Lefebure and possibly our resident Stewart expert Dani Alldrick into our committee. I appreciate Jeff Abbott's offer to help but I think I'll keep things in the family, at least for now.
- I look forward to hearing about your Chinese trip last March.

Dear Andre:

Thank you for the outline of the SEG trip to BC in 1988. I tried to reach you several times by phone before I left for Denver but to no avail. Anyhow, your proposal was well received by PPC and you may proceed with the next stage of planning. In answer to your specific questions, I have the following:

- 1. Insurance yes, SEG does have a procedure for this. You should contact the Treasurer for details. He is Dr. D.(Don) Davidson, Jr., Chairman, Dept. of Geology, Northern Illinois University, Davis Hall 312, DeKalb, Illinois 60115-2854, U.S.A. His phone:(815) 753-1943. I mentioned to him you would be
- 2. Profit/loss SEG field trips should be budgeted to not lose money, of course, but a small profit won't jeopardize our non-profit status with the US IRS. A small loss would be covered by SEG. It was suggested by PPC that, to get a feeling for what kind of response you might get for the trip, you might include a questionnaire flyer in an SEG mailing sometime soon. - 3. Seed money Council voted you \$3000(US) for this purpose, to be made available April 1/88. Sometime well before then (preferably before the next SEG meeting in Phoenix), you should prepare a statement on how and when this seed money would be returned to SEG.

1. SEG has decided to go ahead with its own Guidebook series. This means (I think) that they wouldn't need to take you up on your offer of a guidebook published by BC Dept. of Mines. However, the entire Guidebook issue is still in the process of being shaken down and you should definitely contact the SEG Guidebook Editor: Dr. T.(Tommy)B.
