Prior to this year's drilling program, MineFill Services of Seattle, WA completed a resource calculation on Silver Coin in compliance with CIMM (2000) Standards at zero cut-off which indicated a total inferred resource that contained an estimated 500,000 ounces of gold and 2.11 million ounces of silver. The inferred resource consists of 11.3 million tonnes grading 1.60 g/t gold and 6.64 g/t silver. Approximately 75% of the total inferred resource falls within the Kansas claim. The 2006 drill program was aimed at possibly doubling this resource. MineFill is expected to begin a revised resource calculation in late November with results expected to be available in the first quarter of 2007. The Kansas claim is wholly owned by Tenajon Resources Corp. Pinnacle and Mountain Boy are earning a 60% interest through the expenditure of \$1,000,000 on exploration over four years.
