Hi Tom:

Thanks for copying me with your query. I have the quick coding forms for Minfile and will be filling them out with information on the Simlock Creek property as fully and accurately as I can, as soon as I can, so that we can get "on the map".

Part of our small (\$50K) program on Simlock this year will be a visit to Barker Minerals (Louis Doyle), Consolidated Pacific Bay Minerals (Gil Brett) and International Wayside (Godfrey Walton) properties to get a handle on the stratigraphy and where the massive sulphides fit in. We will be concentrating on potentially-mineralized massive sulphides ("Bonanza"?) near Simlock Creek as identified historically by Amos Bowman as "ironstone ledges".

If you let me know who to keep in touch with regarding our program, just send me an e-mail. I anticipate a 15-20 day program (geochem, +/- mag, mapping, prospecting) in early June (snow permitting) with a 10-15 day follow-up (mainly hand trenching with the aid of explosives).

>I would like to know how one goes about having mineral occurrence(s)
>listed on Minfile. I am involved in the exploration of a lode gold,
>silver, lead, zinc property in the Cariboo (the Simlock Creek property)
>that has mineralized showings (for example - over 2 ounces Au in place -
>chip sample over 1.6 meters). This occurrence has never been catalogued
>on Minfile. We will be spending \$50K flow-through on the Simlock Creek
>property this year.
