

DEAR SHAREHOLDER:

As we have informed you in our last news release of October 20, 1986 we have received \$570,000 flow through funding from the First Exploration Fund. Since the funds have arrived we have continued our exploration programs and are presently working with full strength in B.C. and Saskatchewan.

ANTON PROPERTY, BRITISH COLUMBIA

The drilling on our property was initiated on November 27, 1986. We are planning to drill 10 to 12 holes. The drill targets are geophysical and geochemical anomalies in the Shannon Lake grid. We previously encountered gold mineralization of up to .16 oz/ton gold in drill core.

We are expecting gold values on our present drill program before the year end.

WAPIYAO LAKE PROPERTY, SASKATCHEWAN

We are presently running an extensive geophysical survey over our established zones of mineralization.
