**RE: Racing River Copper Project** 

This is to summarize my phone comments on the above.

The properties mentioned in the International Lornex Inc. letter are known to us as copper-silver vein deposits or prospects. As the letter states, the old Churchill Copper Mine does have reserves, but they are rather modest. The Davis-Keays Mine has had extensive underground exploration but is neither "fully developed" nor is it "ready for production".

The statement that these properties collectively contain "20 million tons .... which will average 5% copper" is, to put it plainly, extremely misleading. Information we have indicates that most of the properties have not been explored sufficiently to establish any kind of reserves, and the reserve figures we do have fall well short of the figures quoted in both tonnage and grade.

We received Mineral Notices of Work forms last year proposing mostly modest exploration work on a number of properties in the Racing River area, and we understand that assessment work was filed in Vancouver for an unknown number of them. As yet we have no details of what was done or where. Our letters seeking a summary of last season's exploration work went unanswered, and the phone number on the Nótices of Work is no longer in service. We also understand, but have not confirmed, that there were some problems with payment of bills to a helicopter company by the operator responsible for this work.

There is no question that the Lornex Mining Corp. name is well known and respected, but none of the expertise associated with that corporation is apparent in this proposal. As I stated, any thought of production is premature until an acceptable prospectus is before the Mine Development Review Committee, and I would not recommend anyone consider production financing until this is done.
