I've learned today that Consolidated Ramrod Gold Corp. has changed its name to QUEST INTERNATIONAL RESOURCES CORPORATION effective last Tuesday, April 9th. Apparently there are no other significant changes, just the name.

Of perhaps further interest, they (QuIRC!) have just completed one 1900' hole on the Vine property, collared SW of the previous long hole on the vein which intersected bedded sulphides at the footwall quartzite. This hole has again intersected the bedded sulphides but they are no thicker and appear to have been somewhat disrupted by faulting (very preliminary report and confidential please!). They pulling the drill out and will re-think the geology a bit before possibly doing more drilling this year (two long holes were originally proposed and have been permitted).

Other projects where they plan small drill programs this year are Fors, Leg and Horn. No more work is proposed this year on the Dean-Allover. Still no word on plans for Goatfell or Cruz dePlata. The Richard Hughes companies (Abitibi, Sedex, Wealth Resources etc.) now have about 2300 claim units scattered through the Aldridge and Glen Rodgers has promised we will be receiving about 23 NoW's. First up will be drilling on the Fran claims located between fors and Vine. (Fran Johnson has sold her land and Glen has staked all the open title and optioned it to Hughes.) This group plans a total '96 expenditure of \$1 million in the Aldridge. Their prime target area is still the "North Moyie".

So much good news this year, once you start it just keeps flowing out!
