

Orphan Boy Resources Inc. Goldstream Willa Gold Project

Planning & Preparation

Representatives of the Revelstoke and Slocan District Chambers of Commerce were canvassed for the most convenient venues and dates that would not conflict with other planned community activities. Resulting from this, evening open houses were scheduled for Revelstoke Community Centre on February 18 2003 and Silverton Memorial Hall on February 19 2003. Lunch presentations to the Chambers of Commerce were also scheduled for the respective days of the open houses.

In the Slocan Valley area (Nakusp south to Nelson) the Silverton open house was advertised in two preceding editions of the *Arrow Lakes News* and *Valley Voice* newspapers and the *Slocan Swami* newsletter. These publications were also provided with project descriptions and carried accompanying articles on the Goldstream Willa Gold Project. In the Revelstoke area, the open house was advertised in two preceding editions of the *Revelstoke Times Review* which has also carried several articles on the Project. In both locations, the newspaper announcements appeared approximately two weeks before, and one week before, the open houses.

The Company provided Project descriptions and open house advertisements to the Revelstoke and Slocan District Chambers of Commerce. Both Chamber newsletters and advisories carried accompanying Project descriptions for member information.

Twenty posters announcing the open houses were placed in strategic locations respectively throughout the Revelstoke and the Slocan Lake (New Denver, Silverton and Slocan) areas during the week leading up to the events. Large format text boards and graphics were prepared, as well as pamphlets, maps, photographs, questionnaires and guest sign-in sheets (see attached). Information on the BC Environmental Assessment Process was provided on the text boards.

Chamber of Commerce Lunch Presentations


The format for both lunch presentations (Revelstoke February 18th and New Denver February 19th) was the same with John Chapman providing a PowerPoint presentation and overview of the Goldstream Willa Gold Project, followed by a question and answer period. Verbal response from the Chamber presidents was markedly similar. Both Chambers:

- expressed enthusiastic support for the Project, citing currently depressed local economies and resultant stress on community services and businesses;
- advised that local infrastructure is an essential lifeline supporting tourism and industry;
- commented that delays due to cutbacks in local ferry service and deteriorating roads were a detraction to visitors and industry; and
- commented that Project transportation requirements would hopefully highlight and support the necessity to restore the Galena Bay ferry to previous service levels.

Of the 32 members attending the Revelstoke Chamber luncheon, all 25 members completing the Project questionnaire indicated support for the Goldstream Willa Gold Project. Of the 16 members attending the Slocan District Chamber luncheon 15 indicated support for the Project, while one was undecided.

Revelstoke Chamber of Commerce Luncheon Project Presentation February 18 2003

Open House Format

A similar format was applied at both open houses, with coffee and pastries provided throughout the evenings:

6:00 p.m. - 6:45 p.m. Guests signed in, examined the text boards and graphics, and spoke with company representatives and consultants.

6:45-8:00 p.m. Ron Coombes welcomed guests, provided the format for the evening and introduced Project Manager, John Chapman. Chapman introduced the consultant team and presented a PowerPoint presentation on the Project.

8:00 p.m. - 9:30 p.m. Question and Answer period.

Revelstoke – February 18, 2003

Fifty-six people attended the event held at the community centre, with 56 signing in and 33 completing the questionnaire provided. Of the 33 respondents, 28 were residents of Revelstoke, three were from Kimberley, one from Logan Lake and one from New Brunswick.

Following the presentation, John Chapman responded as follows to questions and comments:

- Q. What would be the daily truck traffic? (The comment made that reduced ferry service saw delays in the summer time, and that cutback from 24-hour service was a disincentive to local tourism and business).
- A. At 500 tpd, there would be 13 round truck trips per day, or approximately 1 truck per hour on a 24-hour basis. It was realized that reduced Galena Bay ferry service was presenting difficulties for Revelstoke. The company would be investigating, possibly with other truck operators, the possibility of approaching government to reinstate the service. Revelstoke Chamber of Commerce had already stressed the matter with the Company and was in support of this initiative.
- Q. How soon for renovations at the Goldstream Mill?
- A. Rehabilitation of the mill would start on receipt of a positive Feasibility Study, permitting and financing target June 2003. At this stage it appears that US\$350 per ounce would allow an acceptable rate of return for proceeding to development. The Feasibility Study currently underway is scheduled for completion by March 31, 2003.
- Q. How many other Projects is John Chapman working on?
- A. Leader Mining, Cogburn project; Gold City, Greenwood project (as significant shareholder in GC); Patricia Mining, Wawa project; among others.

Q. Would there be an assay lab at Goldstream?

- A. At this time we are planning to send samples from Goldstream and Willa to off-site independent commercial laboratories.
- Q. Would someone oversee both Projects?

- A. Yes. Probably one person at the Goldstream site would oversee all aspects of the operations. Procon would operate and manage Willa, but the Company would have a geological representative on site to plan and monitor grade control.
- Q. How many people would work at the mill and how many would come from Revelstoke?
- A. About 30 people would work at the mill. Company policy would be to hire the best people available while giving preference to local hiring. At Goldstream the plan is to reopen as a union-free operation with everyone on staff with equal profit sharing.

Revelstoke residents were requested not to complete the Project questionnaire until they were comfortable they had sufficient information and understood the nature of the proposal. Following the presentation and the question and answer period, 100% of questionnaire respondents answered 'Yes' in response to the question: *If the Project can meet all the requirements of the BC Environmental Act would you support it?*

Silverton – February 19, 2003

About 115 people attended the event held at the Silverton Memorial Hall, with 112 signing in and 95 completing the questionnaire provided. Of the 95 respondents, one was from Edmonton, one from Kaslo, two from each of Sandon, Slocan, and Hills, 3 from Rosbery, 3 from Nakusp, 8 from Nelson, 27 from Silverton, and 46 from New Denver.


Following the presentation, John Chapman responded as follows to questions and comments:

- Q. Would the Project have an impact on local services?
- A. Yes, in a positive way. The operation would pay taxes that would assist in maintaining local services.
- Q. What about the Galena Bay Ferry?
- A. There is one ferry that operates part of the day, and there is a standby second ferry parked at the dock and brought into service at peak times. The Company, perhaps in cooperation with other truckers, will approach the BC Ministry of Transportation & Highways on reinstating the traditional, or an expanded, sailing schedule. Revelstoke Chamber of Commerce and residents and Slocan District Chamber of Commerce have advised this initiative is necessary and they would welcome and support it. The Project requires 13 round truck trips per day so it would not significantly add to the existing volume of heavy truck and light vehicle traffic on Highway 6.
- Q. Previous concerns were raised regarding acid mine drainage. Will this be a concern with the proposed operation at Willa?
- A. The whole Slocan Lake area is naturally mineralised, explaining how Red Mountain Road got its name. Notwithstanding earlier forecasts of potential ARD, water discharging from the underground and dumps that have been exposed for over fourteen years, is not acidic. An earlier report in May 1990 prepared by Robert L. Hallam Environmental Management additionally contained information indicating that the Willa ore and waste rock would not present an ARD problem. Also, adits and dumps dating back to the late 1800's at Willa show no ARD.
- Q. What about water quality in Aylwin Creek?
- A. ARD was not perceived to be a problem. Run-off containing minor nitrates (from explosives) would receive natural treatment on site by being channeled through a vegetated drainage field after passing through two settling ponds and skimmers before discharge. The resulting discharge to Aylwin Creek would be close to drinking water standards and pose no threat to the area surrounding the Willa operation. Parameters for safe discharge would be set by Water, Lands and Air Protection and contained in the Waste Management Permit.
- Q. Would someone living nearby feel the effects of blasting?
- A. (John Chapman asked if anyone had previously lived near the Willa property while underground blasting had taken place). One person responded that he had lived not more than a mile and a half away, northwest of the active operation, and had never heard or felt blasting. No other response was received.

- Q. Sometimes the area becomes tinder dry in summer. Would there be an added danger of fire?
- A. The Company will operate with high standards of safety and housekeeping, equal to or greater than set by government. Specific fire prevention and suppression protocols will be established based upon the Willa surface setting.
- Q. Northair found the Willa to be uneconomic. What's changed?
- A. The Company's proposal uses an existing mill. The reduced capital cost of trucking to an existing mill compared with Northair's plans to move a concentrator on site improves the Project's economics.
- Q. Would there be dust and noise in the surrounding area?
- A. Again, the Company will work to high standards of noise and dust suppression by meeting or exceeding government standards. Immediate neighbors will be consulted to ensure the Company's practices mitigate to a reasonable degree any impacts beyond the Willa property limits.
- Q. What is the condition of the underground workings? Do they require much work and are they safe?
- A. The underground at Goldstream is closed as the deposit is depleted. The underground workings at Willa are in very good shape, are safe, and require little work to prepare for ore extraction.
- Q. What is your policy on unions?
- A. I have extensive experience with union and union-free operations. I prefer union-free as it makes for a more efficient and positive work environment. When a company treats its employees with respect (as adults and innocent) and involves them in decision making and profit sharing then there is no need for a union.
- Q. Will the operation be short-term? People need long term stable jobs.
- A. The currently proposed operation at Willa is for four years. Successful exploration on site could substantially add to the resource and the mine life. Indications are that the price of gold will continue to rise over the coming years to maintain and enhance economic viability of the Project. Additionally, the Company has acquired several other properties in the vicinity (the Big Bend Metals Project) that, subject to economic viability and permitting, could provide feed to the Goldstream mill. Residents could inform themselves on the other properties and keep up-to-date on developments through the Company's website at www.orphanboy.com.

The Slocan Lake audience was requested not to complete the Project questionnaire until they were comfortable they had sufficient information and understood the nature of the proposal. Following the presentation and the question and answer period, 89% of questionnaire respondents answered 'Yes', 6% were undecided, and 5% answered 'No' in response to the question: *If the Project can meet all the requirements of the BC Environmental Act would you support it*?

Those respondents undecided (6%) or not in favour (5%) of the Project at this time (with two exceptions from New Denver) are residents of the Silverton Red Mountain Subdivision who express concerns regarding water quality, traffic, dust and noise impacts. Importantly, of these residents not in favour or undecided, 6 provided shared addresses, reducing the actual number of households not in support or undecided to five. (Refer to questions and answers previously provided relating to the topics cited).

The majority of questionnaire comments provided by those supporting the Goldstream Willa Gold Project (89%) referred to the necessity for new industry on an economic basis, to provide jobs and contracting opportunities, maintain businesses, local services and local infrastructure.

¹ Approximately twenty more people joined the audience subsequent to this photograph. Additional chairs brought out were taken, resulting in standing room only at the back of the Memorial Hall by the end of the presentation period.

For transparency and insight, all questionnaire comments are attached as Appendix A.

Consultation Summary

In my experience in the review of over forty new mine proposals in British Columbia over a period spanning approximately twenty years, it is unusual to receive such widespread and enthusiastic community support for a new mining proposal as that received by the Goldstream Willa Gold Project.

The explanation is unequivocal: Rural communities in British Columbia are the most important contributors to our 70% primary-resource based international exports, and are the most sensitive to and feel the direct impacts of, closures or reductions in the primary resource sectors. The Revelstoke and Slocan Valley areas are no exceptions.

Overwhelmingly, residents of both community areas refer to the deteriorating forestry-based economy and, as a result, high unemployment rates, rising dependency on the safety net, population drift, and threatened closures of health and education facilities. In the Slocan Lake area in particular, the Project is received as the only proposed new economic initiative to alleviate deteriorating economic and social conditions.

Importantly, on a regional basis, the Project is also appreciated for its potential to highlight the necessity to restore the Galena Bay ferry service to previous levels. This initiative is reported as essential in order to maintain or enhance local tourism and other industries.

There are, however, residents in the Slocan Lake area (11% or 10 persons mostly in the Red Mountain Road area, from five households) who worry they will be impacted by the Project and are undecided or feel they cannot support the Project at this time. In this context, the Company informed the open house that it is sensitive to respondents in the vicinity of the Project regarding perceived water quality, traffic, dust and noise impacts. To address these concerns, the Company has committed to designing the Project to ensure it meets or exceeds Waste Management Permit parameters and provisions of the B.C. <u>Mines Act and Health, Safety and Reclamation Code</u>. In particular, the Company has committed to working with immediately adjacent residents in Project planning to reduce aesthetic impacts to the maximum extent economically feasible.

Overall, the relatively environmentally benign nature of the Goldstream Willa Gold Project (existing mill at Goldstream + existing underground development at Willa + existing road infrastructure) has afforded a high level of public environmental acceptance, while generating a commensurate high level of enthusiasm for this strategic economic initiative.

- My only question: Can the cost of trucking raw ore from mine to mill cancel the lower capital cost? I hope not.
- Some kind of commitment to use local services, resources, facilities, as possible. I would like to see access to the underground at certain times (sightseeing for locals and schools). Basically tours to take pride and ownership locally (job shadowing for youth). Maybe some opportunity for locals to invest directly?

Silverton Open House

Not in Support:

- ¼ km from mine entrance. As a local resident I am very concerned with noise potential (trucks coming down hill, blasting). I am also concerned with fire potential due to industrial activity nearby.
- Worried about environmental impact, noise and dust, wear and tear on Red Mountain Road, danger to local traffic, drinking water issues.

- I live opposite the proposed mine. I'm concerned about noise, pollution to air and water, effects on property values and quality of life.
- I am directly affected by the proposed Willa mine as my property borders it and my domestic water intake is downstream. I am concerned about deleterious effects on quality of life and property values not to mention potential noise, pollution etc.
- What impact will you have on drinking water sources for local residents? How will you monitor this? How much forest will you cut? Can you prove you won't ruin water sources with your machinery? Will you guarantee you'd keep noise levels tolerable for locals? Dust levels? Wildlife habitat damage? (New Denver resident).

Undecided:

- Helpful, courteous consultants and reps. My family and children are feet off the hwy in Silverton. Would strongly prefer covered trucks. Would support 500/tonne a day. 1,000 and 26 trucks seems a far heavier impact – both on road conditions and quality of life in Village. At that point it would be far more difficult to support the project.
- How will the trucking process alter (or not) the south end of Red Mtn Rd? As a regular user of this road, this is of concern to us. (Red Mountain Road resident).

Orphan Boy Resources Inc. is a public British Columbia Company listed on the TSX Venture Exchange under the symbol ORS. The Company's mineral land holdings, all in the Revelstoke to Silverton area of British Columbia, Canada, include 764 mineral claim units and three mining leases for a total of 19,370 hectares. 


