FOOTWALL REPORTS HIGH GRADE GOLD AND ASSESSES MAGNETITE VALUES

FOOTWALL is conducting a two pronged examination of its 180 claim unit, 30 square mile property near Zeballos, on the west coast of Vancouver Island, British Columbia.

High grade gold values have been revealed by drilling into the quartz veins and skarn zones of the Hiller Group. On the Churchill Group reserves of 5.7 million tons of magnetite have been established through work done in the 1950's and 1960's.

Dynamic's research shows Magnetite concentrate, which has numerous and essential industrial uses, is in relatively short supply and is currently commanding a price of \$80-100 per metric tonne. Exploitation of this resource has the potential of adding multi- millions of dollars to the value of this property.

Drilling into the gold bearing skarn zones in the Hiller claims, in the most northwesterly area of the group, has intersected gold mineralization in 16 out 32 diamond drill holes, values to 9.03 ounces of gold per ton over 6.5 feet have been reported.

An exploration program which will total \$1,000,000 on the Churchill-Hiller Group has commenced, the camp has been established, a road to the portal has been built and 160 feet of drifting and crosscut drifting has been achieved.
