## WINSLOW GOLD CORP (WGC-V)

LARDEAU LEAD ZINC PROJECT - Winslow Gold Corp. president TO BE TESTED FOR GOLD Gerald N. Ross has reported

a \$250,000 program has started on the 32 unit (2,160) hectar, 100% owned, Trout Lake claims along Silver Cup Ridge, approximately 9 kilometers south of Trout Lake, Lardeau District, B.C. Work has included clearing of an existing road and setting up platforms for a 600 meter diamond drilling program. The drilling will concentrate on known mineralization to verify underground gold values and width's of vein systems.

The Winslow group claims were explored between 1934 and 1941, approximately 600 oz.gold/t and 300 oz.silver/t were produced from the property.

To date, approximately 1000 feet of underground workings, driven from four separate adits have explored the vein over a vertical distance of 300 feet and a horizontal distance of over 400 feet. Mineralization consists mainly of pyrite with lesser amounts of galena, sphalerite, and rare free gold.

The Granges Goldfinch project is 30 km northwest of the Winslow claims.
