MORE REMAC DRILLING RESULTS - Kristian Ross, president, Redhawk Resources Inc.

reports drill hole assay results from Zone F at its Remac zinc oxide project located 35 km southeast of Cominco's zinc, lead smelter complex at Trail in southeast BC and 16 km north of the Pend D'Oreille zinc mine where Cominco recently announced a production decision. Zone F was tested with two reverse circulation holes. (SEE ASSAY TABLES OVERLEAF P.1) A Zone F drill hole plan map is OVERLEAF P.2. The Zone F zinc oxide zone remains open to the east and west beyond the two holes reported above and is projected to extend downwards to the interface with the previously mined sulphide ore.

The balance of the results, from Zones G and H, are expected in the next three to four weeks. The Year 2000 program was successful in locating and in testing for structural continuity and zinc grades in the oxidized portions of Zones B, C, F, G and H.

Mineralization on the Remac property consists of a series of carbonate-hosted base metal deposits known to extend over a distance of three km on a southwesterly trend. The present program is targeting the oxidized upper portions of these deposits. Based on underground mining and drilling records, oxidation of these deposits ranges to depths of 450 metres.

Drill hole samples reported in this news release were collected under the supervision of George Gorzynski, P.Eng., and Gerald Klein, P.Eng. 'Assay/analytical results were compiled by Mr. Gorzynski. Duplicate pulps of every 20th sample are routinely sent to ALS Chemex Labs in North Vancouver. BC, for confirmation assays.

Redhawk is the operator of the Remac project which is being funded by ZincOx Resources BV. The agreement calls for ZincOx to carn a 50% interest in the property by spending an optional \$3,000,000 over four years. ZincOx, based in London, England, is a world leader in the beneficiation of zinc metal from an oxide source. On 29Sept2000 Redhawk reported its second zinc oxide project, the Torlon project in Guatemala. Like Remac, Torlon is being explored in conjunction with ZincOx.
