MORE WORK RECOMMENDED - Eastfield Resources holds
FOR TWO SE BC GOLD PROJECT two very prospective
intrusion related gold prospects
in southeastern B.C., the Crowsnet and Howell properties. These
properties cover two large clusters of alkaline intrusions which are
associated with widespread gold, indicative of both high and
low-grade bulk tonnage deposit potential.

International Curator has advised Eastfield that it is terminating
the Crowsnet property option, effective February 29, 2000.
International Curator Resources Ltd. funded an exploration program
in 1999 that comprised extensive grid controlled geophysics,
geochemical sampling and drilling. This work was directed at
locating the source of numerous high-grade gold mineralized
boulders and resulted in the definition of an area 500 meters by 500
metes that shows a good potential for further oz/ton gold across 16.5
meters. The drill program tested various geophysical targets and
succeeded in locating several large occurrences of highly altered
syenite intrusion. Anomalous gold values in the drilling were
localized and no ore grade values were intersected.

Howell Property:

The Howell Property is held under option from Placer Dome
(CLA) Limited and Cominco Ltd. Previous exploration Cominco,
Placer Dome and Phelps Dodge outlined extensive syenite intrusive
bodies and several related soil gold anomalies over an area of 12
square kilometers. Preliminary drill testing has been undertaken on
portions of two anomalies and more extensive drilling tested a
portion of a third anomaly. Highlights of the drill results include
hole HRC25 which returned 405 ft (123.4m) of 0.7 g/t gold,
including 190 ft. (58m)
grading 1.23 g/t gold, hosted in silicified limestone. Anomalous
gold values were intersected in almost every drill hole. Large areas of
anomalous gold soil geochemistry have had little to no follow-up
exploration.

Evaluation work by Eastfield in the late fall of 1999 determined
that several targets require detailed exploration, including the area
surrounding hole HRC-25. Eastfield has held discussions with
several junior and senior companies with regard to participation in
these gold projects in the Flathead region of southeastern B.C.
