MERRITT-KAMLOOPS - Leonard Saleken, P.Geol. president,
CLAIMS STAKED reports Goldcliff Resource Corp. has

acquired, on its own behalf, two claim blocks totalling 21 claims in the Merritt-Kamloops area of south-central BC. The S and V claims are 100% owned by Goldcliff, and are free and clear of any encumbrances. Goldcliff's Meadow Creek property (S claims) that was originally staked in 1995 consists of 1,200 hectares. The new staking (15 claims) brings the total holdings to 1,490 hectares in one contiguous block. The southern boundary of the Meadow Creek property adjoins the Gitennes Exploration Inc. and Platinova A/S claim holdings. The V claims (Powerline property) consist of six units totalling 150 hectares and are located 2.5 km west of the Meadow Creek property. The V claims adjoin the northern claim boundaries of Gitennes and Fjordland Minerals Ltd. Both properties are accessed from the Coquihalla Highway, which runs north from Merritt to Kamloops. The staking rush resulted this fall after Gitennes reported the discovery of a new high-grade polymetallic volcanogenic massive sulphide (VMS) outcrop (Blacktop prospect) on its Fox property.

Goldcliff's properties are located 230 km northeast of Vancouver and 40 km north of Merritt. Access to and on the claims is excellent. The Meadow Creek property contains the Plug and Meadow Creek prospects (gold, silver, copper, lead, zinc) plus several geochemical (copper, gold, lead, zinc) and geophysical (magnetic) anomalies. The Powerline property contains no known mineralization but covers the geological contact associated with the Blacktop prospect of Gitennes. Goldcliff's two properties are located about nine km north of the new high-grade zinc, copper, lead, silver and gold volcanogenic massive sulphide (VMS) Blacktop prospect and in similar geology. A Gitennes press release published in GCNL NO.228, P.1., Nov.29, 2000, with a location map, reported mineralized outcrops containing values of 19.75% zinc, 1.58% copper, 0.52% lead, 98.1 grams silver/tonne and 0.54 grams gold/tonne.

Located in BC's "Copper Triangle", the Blacktop discovery initiates a new wave of exploration in the region. The Copper Triangle (Kamloops-Ashcroft-Merritt region) has undergone extensive claim staking over the last 100 years. This is the third time within the last 40 years that the region has been re-staked for its mineral potential. During the 1950s, 60s and 70s, this activity led to the discovery and development of several mines. These include the porphyry copper, molybdenum deposits in the Highland Valley (Bethlehem, Lornex, Valley Copper, Highmont), the skarn-replacement copper deposit at Merritt (Craigmont), and the porphyry copper, gold deposits at Kamloops (Afton, Ajax). In the
