HOWELL FIELD PROGRAM BEGINS - J.W. Morton, P.Geo.,
Eastfield Resources
Ltd., reports fieldwork has begun on the Howell property about 40
km southeast of Fernie, BC and 17 km west of the BC-Alberta

boundary. The property consists of the 88-unit Howell claims recently 100% optioned from **COMINCO LTD.** [CLT-T, M] and **PLACER DOME INC.** [PDG-T, M] and the 18-unit Ysoo claim acquired by staking in November 1998. The southeastern boundary of the project claims is situated within three km of the northwest boundary of the Crowsnest project claims, which are subject to a joint venture between Eastfield and Int'l Curator Resources Ltd.

Previous exploration by Cominco, Placer Dome and Phelps Dodge on the Howell claims has outlined a large area of gold mineralization related to the syenite intrusions and occurring within the hosting limestone and calcareous sediment stratigraphy.

Prior highlights of exploration include drill hole HRC25 which returned 190 feet (58 m) grading 1.23 grams gold/tonne, hosted in limestone. Substantial intervals of sub-economic gold values were intersected in a number of other drill holes both in syenite and in limestone (e.g. 0.48 grams gold/tonne over 72 metres, 0.44 grams gold/tonne over 63 metres and 0.41 grams gold/tonne over 40 metres). Large areas of anomalous gold soil geochemistry have had little to no follow-up.

The fall 1999 program is concentrating on completing rock sampling in areas which have had little or no prior work. Of particular interest in the exploration potential of the numerous diatreme breccias, which occur on the claims. The diatremes were previously thought to be post mineral and have largely been ignored. Recent sampling completed on one of these bodies returned a consistent anomalous result with two of three samples taken exceeding 0.50 grams gold/tonne. Several diatreme bodies have been documented on the claims with the largest one exceeding 150 metres by 500 metres in size. It is expected the current work program will continue until early November.
