Mr. Reaugh says all the holes and trenches referred to in this release are contained within an open area 100 meters wide by 150 meters long. The average thickness of mineralization has been calculated to be 3.56 meters all of which is within a depth not exceeding 120 meters at the deepest point. Thus, the overall significance of these data is that this portion of the high grade Silver Zone contains metal values which exceed \$750,000 Cdn. per ton.
