PRILL FUNDS BEING SOUGHT - John 6. Robertson, president, FOR SILVERKNIFE PROJECT reports that Reg Resources

Corp. plans an aggressive drilling program on it's Silverknife claims in the Liard mining division in northern B.C. contiguous to Regional Resources' Midway and Silver Creek silver, lead, zinc discoveries.

Reg's work in 1985 and 1986 resulted in discovery of an excellent silver, lead, zinc, zone. The best intersections carried 29.23 ounces of silver per ton and 17.31% lead/zinc combined over 14 feet.

According to Dr.Gary Medford, consulting geologist, this zone may be expanded to about 1,000,000 tons or more of near surface mineralization by drilling along the geochemical anomalies.
