SKYLARK RESOURCES LTD. (SKR-V) TOODOGGONE RIVER DRILLING PLANNED - Skylark Resources

Ltd. has discovered a third high grade gold/silver discovery, the (Electrum Zone) at its Finlay River project in the Toodoggone Gold Camp. B.C. Initial assay values of 2 grab samples gave 0.276 oz/ton gold, 31.30 oz/ton silver; and 0.209 oz/ton

gold, 35.48 oz/ton silver. Outcrop measures approximately 15 ft. wide by 50 ft. long and contains visible electrum and argentite on surface. Both the Electrum and Beaverdam Zones have the potential to host multi-million ton deposits and are scheduled for initial drilling in July. The property which contains the Beaverdam and Electrum showings is under option from ASITKA RESOURCES LTD (ATK-V). On the Finlay River project detailed sampling has started of the high grade 4.46 oz/ton gold, 3.25 oz/ton silver, multi-vein system in the Wrich zone. These veins vary in width from 1 ft. to 10 ft. on surface, dip vertically, are open on strike, and are contained within an area 1500 ft. wide by 600 ft. long. The Wrich claims are under option from Cheni Gold Mines Ltd.

Skylark has options to earn 50% working interest in these properties totalling approximately 23,000 acres.

<u>RULE RESOURCES LTD</u> (RUL-V) has started a \$300,000 exploration program on the <u>Golden Stranger property</u>, <u>Toodoggone region</u>, <u>B.C.</u>, held jointly with Sutton Resources Ltd. and Redfern Resources Ltd. Between 6,000-8,000 feet of drilling will concentrate on the 2,400 foot strike length along the main zone. Rule Resources Ltd. has granted options on 135,000 shares at 21¢ exercisable to 29Jun90, subject to regulatory approvals.

<u>TRIUNE</u> <u>RESOURCES</u> <u>LTD.</u>(TRB-V) has reported no commercial values from three diamond drill holes on the <u>Dumas</u> <u>Gold</u> claims. A new property is sought. The company has approximately \$85,000 of working capital.

ISKUT EXPLORATION STARTED- The 1988 exploration programs

will start soon on the Iskut River property of Hector. The programs will include trenching, prospecting and diamond drilling to continue evaluation of several known gold showings. Much of the exploration program will be concentrated in the area of the Golden Spray Zone. Diamond drilling in 1987 resulted in the discovery of an anomalous area of auriferous quartz/pyrite veining which is known to extend over 3,000 feet in strike length.

Hector has recieved \$80,0112 from Mankay Investments VIII Limited Partnership as recovery of certain Canadian Exploration Expenses incurred on its properties during 1987.
