interest from Columbia by spending \$8,000,000 on exploration over four years. Drill holes 91-65  $(-60^{\circ})$ and 66  $(-48^{\circ})$ , collared at the same location, intersected the zones about 60 feet south of Section 9909 and tested up to 197 downdip of hole 91-63. Noles 91-64, 67 (lost due to caving) and 68 were located 115 feet to the north of Section 9909. Based on assays and interpretation, hole 65 appears to have intersected the Porphyry zone; however, was stopped short of the QC zone. Both the Porphyry and QC zones were intersected in hole 66. This establishes a minimum vertical depth of 344 feet of mineralization at this location.

Holes 91-69 and 70 were planned to intersect the target gold zones 131 feet south of Section 9909 and above hole 90-56 which returned 5.0 feet grading 0.32 oz.gold/ton and 11.0 feet of 0.21 oz.gold/ton; both intersected the vein structures. Visible gold mineralization is reported in a 39.7-foot long interval in hole 69 and in a 17-foot long interval in hole 70.

Geological projections of the zone to the north suggest drill holes 64, 67 and 68 are in the footwall to the vein structures. It is postulated the zone has been shifted eastwards by an intrusive monzonite dyke. Continuity appears confirmed by an area of strong gold-in-soil anomalies. As such, drilling east of holes 64 and 68 is currently in progress via drill holes 71 and 72, which are drilling westward across the same section line to make a scissors-like test of the target extension. Geological projections of the zone to the south have been confirmed by a new prospecting discovery of gold-rich quartz veins in outcrop some 280 feet south of hole 69, or 394 feet south of 63 on Section 9909. This suggests the potential to establish more reserves in the southern segment is excellent. Testing of this extension will start after completing hole 72.

Dr:11ing continues to test the Porphyry and WC zones as well as surface prospecting and mapping. Drill results to date suggest the Porphyry and QC zones are open along strike north and south, and to depth. A drill hole location map is being prepared.
