ports various companies in the Prime Group have received discouraging exploration results from properties in the Iskut River area about 70 miles northwest of Stewart. B.C. Eurus Resources Ltd. and 50/50 joint venture partner Thios Resources Ltd. completed a geological, geochemical and geophysical evaluation of the Rock & Roll property. Exploration focused on defining the Black Dog horizon which hosts the volcanogenic massive sulphide Black Dog deposit. Airborne geophysics traced the horizon for seven km of strike length. The Black Dog deposit itself contains a preliminary geological

reserve of 640,000 tons grading 0.072 oz.gold/ton, 9.8 oz.silver/ton, 0.79% lead, 3.08% zinc, 0.64% copper.

Three recent holes on the Rock & Roll property intersected graphitic argillite horizons. Drilling included a 150-meter step-out hole to the south of the Black Dog deposit, an initial hole on a parallel geophysical target and an initial drill hole on a strong geophysical target located north of the Iskut River, two km northwest of the Black Dog deposit. No significant value were encountered and no further work is planned.

Adrian Resources completed its program on the Phiz property, 3 km east of the Black Dog deposit comprising airborne geophysics, prospecting, geological mapping and basal till geochemical sampling. No drill targets were outlined and no further work is planned.

Collins Resources Ltd. completed airborne surveys, prospecting and mapping on the Mount McGrath property 18 km west of the Black Dog deposit. No targets were found.

Consolidated Regal Resources finished exploration at the Thunderstruck property 12 km northwest of the Black Dog deposit. No targets were found.

Canadian Eagle Explorations completed its program at the Rhythm and Blues property, 12 km. northwest of the Black Dog deposit, comprised of airborne geophysics, ground VLF-EM, prospecting and drilling of hole RB91-01. No significant results were returned.

Galico Resources Inc. completed its program at the Wiseguy property comprising airborne surveys, prospecting and geological mapping. No drill targets were found.

Halcyon Resources Ltd. completed an airborne survey, prospecting, and geological mapping on the Rockabilly property 10 km west of the Black Dog deposit. No drill targets were found and no work is planned.

Tymar Resources Inc. and Consolidated Goldwest Resources Ltd., 50/50 joint venture option holders, completed their program at the Teryl Option property 3 km east of the Rock & Roll claims. Work comprised airborne geophysics, ground VLF-EM and horizontal loop-EM prospecting, basal till sampling and diamond drilling of hole TY910-01 on the Boundary Creek zone. Results were not encouraging and no more work is planned.

Wirlwind Resources Ltd. completed a program on the Craig River property immediately south of the Rock & Roll claims, including airborne geophysics, prospecting and mapping. No targets were found and no more work is planned. (SEE GCNL No.187, 27Sep91,P.1 FOR PREVIOUS DATA)
