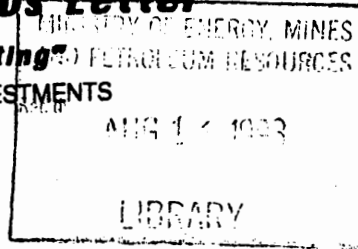

## NEWHAWK GOLD MINES LTD. (NHG-T)

**SULPHURETS DRILL RESULTS** - Donald McLeod, president, reports Newhawk Gold Mines Ltd. has received initial results from the 21,000-foot surface diamond drilling program currently in progress at the Sulphurets property, located 60 km north of Stewart, northwest B.C. On the 60%-owned Bruce side project (GRANDUC MINES LTD., 40%), 11 holes totalling 1,391 meters have been completed on the S.G. and Galena Hill zones. Significant results for seven of those holes are listed overleaf P.4. This drilling tested the zone along 80 meters of strike to a depth of about 75 meters. The zone is open to the west and at depth, with a steep dip to the north. Further drilling is planned. At Galena Hill, (see second table) the results of the remaining four holes are expected shortly, but visually they appear encouraging.

Mapping and sampling continues on various other zones on the property. Continued interpretation of the Gossan Hill/Tommyknocker area has identified a narrow high grade zone called PM-4 (see third table) sampled by 13 trenches and drill holes. The zone appears open along strike with a suggested northeasterly plunge.

On the 100%-owned Snowfield project, the second of several deep diamond drill holes has begun to test the potential for higher grades at depth and to examine the zone to the southeast. Previous drilling has outlined an in-situ resource of about 7,000,000 tons grading 0.075 oz. gold/ton with potential for a significant increase in tonnage. Programs at Bruce side and Snowfield will continue until late September. (SEE GCNL NO.129, 7Jul93, P.2 FOR PREVIOUS PROJECT DETAILS)

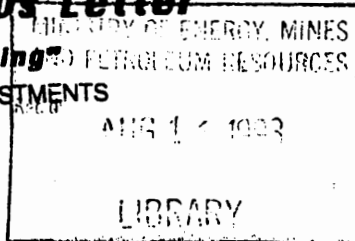
