NEW POSSIBLE PORPHYRY-COPPER ZONE- Willis W. Osborne, CEO reports Westpine

Metals' discovery of the Buzzer West Zone on the Taseko Property located 140 miles north of Vancouver BC. This zone has been traced for 900 feet on the ground through the location of intrusive rock fragments mineralized with disseminated chalcopyrite and molybdenite.

Results from a soil sampling survey with values up to 1,282 parts per million copper indicates that the zone could extend for 2,000 feet with a width of up to 600 feet open on both ends. The copper soil anomaly is part of a series at copper soil anomalies extending over a length of 8,000 feet. The full geochemical picture is obscured in places by a cover of glacial drift.

The Buzzer zone is 1,800 feet to the northeast of the Buzzer West. Old reports indicate the Buzzer to have 5,500,000 tons of 0.35% copper 0.031% molybdenum with gold values. When analyzing the drill samples only a portion were run for gold. The rock at the Buzzer appears similar to that at the Buzzer West. At the present time the spatial relationship between the Buzzer and the Buzzer West is not known.

The Taseko property also indicates the Empress area where a mineral reserve of 11,000,000 tons of 0.61% copper and 0.023 ounces per ton gold has been outlined in intensely altered volcanic rock. This includes 915,000 tons of 1.91% copper and 0.066 ounces per ton gold. The East Zone similar to that of the Empress area in the nature of mineralization and geological setting occurs 3,300 feet to the east of the Empress. This zone has not been defined. The geological environment in which the Empress and East Zones occur has been traced for 15,000 feet.

Westpine also holds an option on a 25% interest in three diamond properties the Elwin Bay the Ham and the Nord located on Somerset island Northwest Territories. The three known kimberlite pipes were

drilled last summer and six new kimberlite diatremes were discovered. 47 F B Results from the summer program are pending. (SEE GCNL NO.179, 17SEPT93, P.3 FOR PREVIOUS INFORMATION).
