director, reports Tenajon Resources Corp. and 50/50 joint venture partner Westmin Resources Ltd. have approved a \$520,000 underground exploration program to start May 15, 1993 on the SB property located 19 miles north of Stewart, B.C.

In 1991, a total of 113,049 tons of ore grading 0.259 oz.gold/ton from the Facecut/35 Zone were successfully mined and milled. This resulted in a profit in excess of \$2,000,000 to Tenajon. As a follow up to this, an underground program to explore the neighbouring Kansas Zones will be undertaken in 1993. The exploration program will provide the first underground access to the Kansas Zones. The program will consist of 130 feet of drifting and 450 feet of raising in waste, and 550 feet of drifting and 115 feet of raising within the Zone. In addition, 6,200 feet of underground diamond drilling is to be completed. A selection of drilling results from holes drilled in past years in the Kansas zones is listed below.
