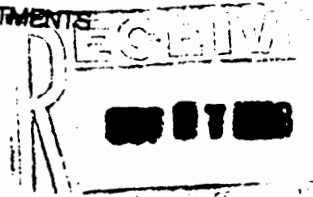

NEW DRILL RESULTS RECEIVED - Richard G. Whatley, P.Eng., president, reports Alpha Gold Corp. has received assay results for the 1993 drilling program on the 100%-owned Lustdust property located about 150 km northwest of Fort St. James, B.C. SEE OVERLEAF P.2 FOR SELECTED 1991, 1992 AND 1993 DRILLING SUMMARY AND MAP. The Lustdust property has four known mineralized zones over a strike length of about one mile. In 1991, a drilling program was done on Zone No.3 located 2,500 feet north of Zone No.1. In 1992 and 1993, VLF, magnetometer and electromagnetic surveying plus diamond drilling was conducted on the No. 4B Zone located about 2,000 feet northwest of Zone No.3. The 1992 and 1993 drilling on the No.4B Zone has extended the mineralization for about 2,000 feet along strike.

Alpha Gold management believes the results are indicative of a complex geological structure which will require further diamond drilling to delineate the nature and extent of the structure. Further work is anticipated for the summer of 1994.

In another development, Alpha Gold is negotiating to acquire an interest in a Nevada gold prospect. The company has over \$400,000 in working capital.
