DRILLING PROGRAM TO START - Donald A. McLeod, president.

Newhawk Gold Mines Ltd. has reported a \$1,500,000 exploration program for the 1994 field season on the Brucside portion of the Sulphurets property, located 60 km north of Stewart in northwestern B.C. SEE MAP OVERLEAF P.2. The property is owned by Newhawk Gold Mines Ltd. (60%) and Granduc Mining Corp. (40%). Newhawk is operator.

Exploration to date on the Sulphurets property has discovered over 40 zones of gold/silver mineralization including the West Zone, where geological reserves of 826,000 tons of 0.45 oz. gold/ton and 18.8 oz. silver/ton have been established.

The 1994 program will consist of 8,000 metres of diamond drilling in two phases, as well as continued detailed mapping and sampling of several promising mineralized zones discovered later in the 1993 field season. The drilling program is designed to test a significantly larger volume of alteration and mineralization than previous years programs, in order to add the potential for significant tonnage to the existing reserves and enhance project economics. Drilling will concentrate in three areas: i) deep drill testing of the Gossan Hill/Tommyknocker Zones about 250 metres below surface; open intersections of mineralization, and iii) testing of the updip extension of the R8 structure of the West Zone at its eastern end.

An advance crew was mobilized to the property June 7, with the remainder of the crew to follow June 21. Drilling is expected to start around July 1.

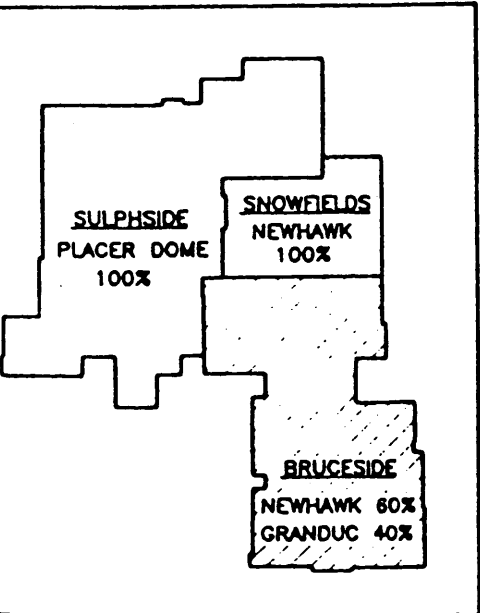
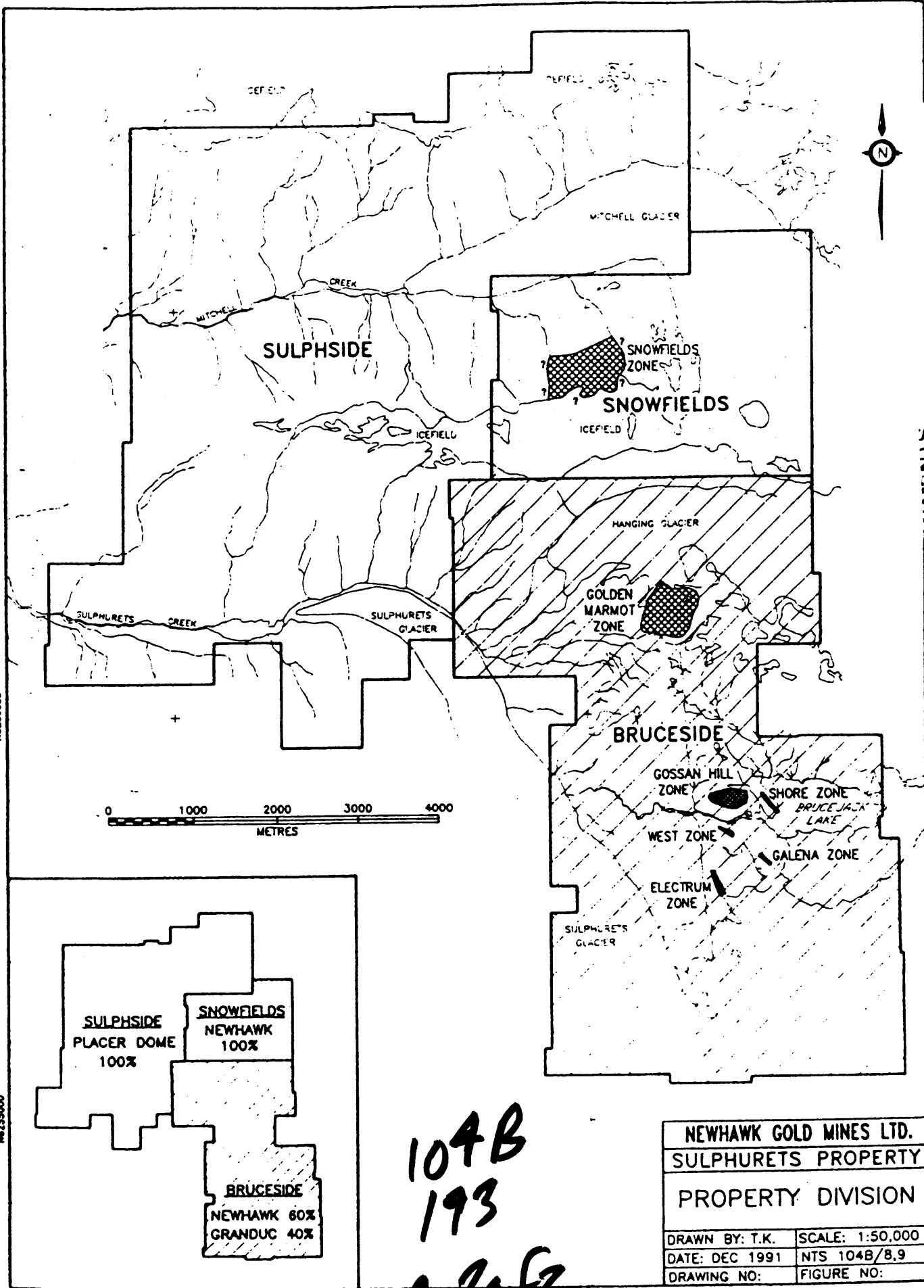
