RAINBOW DRILL RESULTS RECEIVED - Victor Coultbard, president Pacific Mariner

Explorations Ltd. has recently completed exploration programs on the 100%-optioned Rainbow property, located about 55 km west of Windy Point, 150 miles northwest of Prince George, 20 km southeast of Mt. Milligan, near Mackenzie, B.C. Exploration results have also been received from the Sun property near Creston, B.C. and the Eureka property, Yukon Territory.

Drilling on the Rainbow consisted of 600 metres of diamond NQ drilling to test two geophysical anomalies resembling Mt. Milligan style targets. Mineralization was encountered in every hole on the K6 anomaly along a distance of one km between holes while the K4 had little to report. Management is encouraged with the results of this preliminary drilling program and has increased its land position over the projected concentrated source of this mineralization.
