MORE RAINBOW ASSAYS - James T. Gillis, president, Getchell Resources Inc., 30%, reports joint venture partner Teck Corp., 70%, has received partial assay results

for Hole 94-22 drilled on the Rainbow property located near Kamloops, B.C. The location of this borehole, and the location of all other boreholes drilled during the 1994 Phase I and II drill programs are shown on the location map overleaf P.1. This borehole has an azimuth of 032.5° and a dip of -45°.


Hole 94-22 intersected a broad mineralized zone of slightly lower grade than that intersected in drill holes 94-14, 94-17 and 94-21. Borehole 94-22 penetrates 35.1 metres of overburden prior to intersecting a rock package dominated by mafic volcanics through to 132.85 metres. From 132.85 metres to the end of the borehole at 292.9 metres, the borehole cuts a mineralized and altered dioritic intrusion. The contact of the mineralized intrusion with the unmineralized volcanic rocks is likely to be sub-vertical. The following mineralized zones are noted:

These intesections are reported as core lengths. True widths of the zone are yet to be determined. Assay results have not yet been received for drill hole R94-23.

A third phase of drilling, totalling a minimum of 6.000 feet, is currently being planned to test the up-dip extent of the mineralized intrusion intersected in DDH's 94-14, 94-17, 94-21 and 94-22. Other areas of exploration interest will also be tested during Phase III drilling. Getchell Resources will be funding 30% of the anticipated costs of this phase of exploration.
