prillhole GS-94-3 intersected a thick ore grade intercept and appears to extend the western boundary of the zone. GS-94-5 intersected the zone at the lowest elevation to date (85-metre elevation) and shows the zone continues to depth. Results from the six-hole program are sufficiently encouraging to warrant completing an additional three holes to further test the zone between the zero and 250-metre elevations. The results of the nine-hole drilling program and the ongoing development of the Goldstream Mine will be used to update the reserves.

The Goldstream Joint Venture's Rain property, located about 20 km southeast of the Goldstream Mine, has been optioned to Keystone Mountain Resources Ltd. which may earn a 75% interest by making \$700,000 in exploration expenditures over five years. Once the option is fully exercised, Bethlehem and Goldnev may earn back up to 35% interest to increase their combined total interest to 60%.

On the Joint Venture's Brew property, located about 70 km north of Revelstoke, a drilling program is being conducted by OTM International Development Inc. which has an option to earn a 50% interest by spending \$500,000 over three years.
