## FIRESTEEL RESOURCES INC. (FIR-ALBERTA)

FINAL ZO PROJECT ASSAYS - David G. Dupré, president, reports Firesteel Resources Inc. has received the final assay results from the initial 10-hole drilling program on the 100%-owned ZO property in the Tulsequah area of northwestern B.C. This program tested a well mineralized shear zone over a strike length of 300 meters and to a depth of 100 meters. The assay results are tabulated overleaf P.2.

In order to estimate the value of these multi-metal intersections, a "Gross Metal Value" column is presented. This value is calculated on a per ton basis for each metal and uses current prices (expressed in US\$). These prices are: gold \$380/oz, silver \$5.50/oz, lead 30¢/lb, zinc 50¢/lb and antimony \$2.50/lb.

A significant proportion of the total gross metal value can be attributed to the high antimony content. The price of this metal, which is primarily used as an industrial fire retardant, has recently triped to \$2.50 per pound.

The second phase of the drilling program has just been completed and assay results should become available within three weeks. This four-hole program tested the central portion of the mineralized zone down dip from several of the most significant intersections encountered during the first phase.
