VANCOUVER ISLAND EXPLORATION REPORT - John L. Pallot,
president,

Westward Explorations Ltd., and partner Cyclone Capital Corp. report preliminary results from the recently completed 1995 field work on the King Gold project have confirmed earlier gold anomalies associated with quartz veining and altered volcanics. Westward holds an option to earn a 50% interest in the King group of claims, located on northern Vancouver Island, B.C., from Cyclone Capital. Detailed soil sampling, mapping, hand trenching and geophysical surveys have highlighted three parallel linear structures in excess of one km in length with associated gold anomalies.

Prior years' exploration work detailed a large area with anomalous gold in soils located about one km northeast of massive quartz vein float discovered on the shoreline of the nearby lake. Further work identified quartz veining in place within the target area, with assays up to 1.7% copper, and up to 1,150 ppb gold.

Peter Dasler, project geologist, reports the current survey closed the main grid to 12.5-metre by 50-metre spacing. One new gold showing consisting of sheeted quartz veins was discovered. Assays of the limited quartz exposures reported trace gold and the altered volcanics assayed 6.8 grams gold/tonne and 0.16% copper. This mineralized occurrence is associated with one of the major geophysical and geochemical lineaments and the occurrence of gold in the wall rock of the veins is encouraging for further exploration. The current work program has detailed the potential of the property to host a large gold mineralized system.

The companies are awaiting final geological reports when further details will be reported. Westward plans extensive exploration of the property, most likely a drill program next year, and meanwhile awaits the finalization of forest roadworks in the area which will facilitate access to the property.
