B.C. EXPLORATION UPDATE - Peter F. Wishart, president, Topper Gold Corp., (40%) in a joint venture with Grand National Resources Inc., (60%) is conducting exploration on the Laredo gold/silver/copper property of 172 units in the Keremeos/Penticton area, 260 miles east of Vancouver, B.C.

The work is being carried out on the Laredo and the Kemo claims immediately south of the large copper/gold/silver anomalous zone which was sampled, assayed, recorded and mapped trending in an east west direction and measuring more than 1.5 miles in length with widths exceeding half a mile.

Near centre of the Laredo zone in the same east-west direction along strike for almost two miles is a high grade Kero Gold Vein system with parallel veins. The gold veins were trenched and drilled near the east side. Eight holes were put down over a length of 2,300 feet yielding an average of 0.475 oz. gold/ton per ton plus good values in silver, copper, lead and zinc.

The Kero vein on the west side near centre of the Laredo zone was exposed by trenching near surface across two feet and was sampled, analyzed and assayed by an independent geologist with the following results: 50.9 oz. gold/ton; 21.45 oz. silver/ton; 1.78% copper; 2.46% lead; and 2.49% zinc. Presently, Topper is conducting work on the Laredo property consisting of VLF (EM) electromagnetic, geochemical survey, soil sample analysis and assaying in efforts to increase the large Laredo zone to the South.

Preliminary results have been received and will continue to be received as there remains some work to be completed which indicates the large Laredo zone extends to the south. Soil samples collected and assayed show significant anomalous copper values from 200 to 840 parts per million (ppm) and silver anomalous values from 0.50 to 3.2 ppm.

Topper Gold is examining other properties in Australia, South America, Mexico and China.
