TAURUS PROJECT ASSAYS RECEIVED - David Hjerpe, president, International Taurus

Resources Inc.. reports the following preliminary assay results from Cyprus Canada's recently completed diamond drill program on the Taurus Project near Cassiar, B.C.. The gold project is being explored by Cyprus Canada under agreements with Int'l Taurus Resources and CUSAC INDUSTRIES LTD. [CUSIF-NASDAQ; CQC-V. T]. Cyprus Canada can earn up to a 70% interest in selected areas. SEE TABLE OF DRILL RESULTS OVERLEAF P.4.

Seven holes were drilled on claims held by Cusac Industries Ltd. to test new anomalies detected by the March 1995 geophysical survey over ground to the west and south of the known Taurus mineralization. Best results were from hole T95-13 on line 11W, 2 + 25 W, near the boundary with claims held by Int'l Taurus Resources. This hole tested between the Taurus West and 88 zones as intersected by holes T95-3 and T95-4 of the March program. T95-13 intersected an upper section of spaced, sheeted pyritic quartz veins. Underlain by a wide zone of disseminated pyritic mineralization. This lower zone returned 1.10 grams gold/tonne over a core length of 108.7 metres. including 3.01 grams gold/tonne over 26.5 metres.

The pyritic zone was intersected in previous Taurus drill holes in the Taurus West Zone, and appears to strike north to northeast and dip shallowly to the east. It therefore projects under previous shallow holes on the 88 Zone to the east and should come to surface further west. Holes T95-8 and T95-9 tested chargeability anomalies 800 and 1,200 metres west of the 88 Zone drilling, on lines 20 W and 24W, respectively. No mineralization was encountered, and the anomalies are explained by graphitic argillite.

Holes T95-10 and T95-11 tested the margins of a large chargeability anomaly in the vicinity of 8W to 12W, 1000S (the History Hill areas). Hole T95-12 tested a similar anomaly at 22W, 1000S (the Mystery Mountain area). Hole T95-14 tested a third anomaly on the flank of McDame Mountain, at 28W 1000N. All these holes intersected pyritic quartz vein mineralization as well, hole 12 intersected a zone of disseminated pyritic mineralization. Although grades are lower than expected, these holes indicate the presence of Taurus style mineralization in three previously untested areas.

Trenching is underway in the Taurus West area, where quartz veins have been exposed.

The summer drill program, consisting of an initial 40 holes with permitting for 120 drill sites, is now underway, with two drills. These will begin by testing for extensions to the pyritic zone in
