ENCOURAGING CARIBOO TRENCH RESULTS - John A. Chapman, president, Gold City Mining Corp., reports results from excavator trenching on the Morning Star Crown Grant of the Williams Creek property at Barkerville, east of Quesnel, Cariboo Gold Camp area, B.C. The sample composites printed overleaf P.1 are limited to those assaying greater than 3 grams gold/tonne.

The Morning Star ground was first explored by the Williams Creek Gold Quartz Mining Company in 1947 where Dr. A.C. Skerl conducted a trenching and drilling program in the area. A swarm of more than 15 separate quartz veins is known to exist on the property and there appears to be a strong association between these veins and major north-south faults. Exploration results to date indicate the presence of a large quartz vein stockwork with high-grade quartz veins in low-grade argillitic wallrock. One of the two diamond drills (Connors Drilling Ltd.) now working at the WelBar Gold project is being mobilized to this area.

Gold City is exploring the 500-hectare Williams Creek property, part of the Welbar project, under an option from Williams Creek Explorations Ltd. Under the terms, Gold City can earn a 50% interest with no NSR by making option payments totalling \$197,500 and spending \$595,000 on exploration over five years.
