WILLOUGHBY PROJECT REVIEW - Fred G. Hewett, vice president of Camnor Resources Ltd., operator, and 50/50 joint venture partner Gold Giant Minerals Inc. report surface drilling portion of the 1995 exploration program on the Willoughby project has been completed and the underground portion is well underway. Willoughby, 26 km east of Stewart, B.C. and adjacent to Red Mountain, recently acquired by Royal Oak Mines Ltd., where a +1,000,000 ounce reserve has been reported.

The purpose of the 1995 surface drill program was to test the North, Wilby, Willow, Kiwi, North/North and Icefall (both Lower and Upper) Zones. Twenty-seven holes totalling 3,013.5 metres were completed. The following is a summary of drill results:
