NOTE: Holes 39-49 represent step-out sites to the east. Drilling has resumed to the northwest where the mineralized trend appears to be striking.

Lloyd Geophysics is presently conducting an IP survey located over the Webbsite Zone and extending to the swamp zone which is located 1,500 feet to the west. Soil geochemistry has indicated an anomalous zone averaging 0.05% MoS<sub>2</sub>, covering an area measuring 1,400 feet by 165 feet in the Swamp Zone.

Preliminary metallurgical test results are not yet complete but indications are that the molybdenum and copper area easily floated.
