WATSON BAR BULK TEST PLANNED - Larry W. Reaugh, president, Stirrup Creek Gold

Ltd., reports the BC Energy & Mineral Division has acknowledged receipt of the company's Notice of Work, dated 15Apr96, on the 70%-optioned Watson Bar, high grade gold property 33 km due west of Clinton, southwest BC. SEE LOCATION MAP OVERLEAF P.1. The company plans to begin a trenching and drilling program once all approvals have been received.

More immediately, Stirrup Creek will start a 10- ton metallurgical test on the high grade zone, whereby a 100-ton sample averaged 1.16 oz. gold/ton, significantly higher than the smaller trench samples indicated. The metallurgical tests will be under the supervision of John W. Fisher, metallurgical engineer.

The company plans the drill program in the vicinity of the trenches which also indicates past diamond drill holes grading up to 0.58 oz. gold/ton over 16.5 feet in hole No.1, 0.105 oz. gold/ton over 33.0 feet in hole No.12 located 350 feet down dip, from hole No.1 and 690 feet down dip from the surface trenches. The drill program will be designed to block out tonnage in the trench discovery area (known as Zone V). There are 13 additional zones identified by trenching, geophysics and geochemistry on the property which require further exploration and drilling. The company has completed the purchase of 100% of the 300 hectare, 12-unit Gold claims, for \$10,000 plus 20,000 shares, situated in the heart of the Bralorne Pioneer gold camp, at Goldbridge, 150 miles north of Vancouver, in the Lillooet mining division, B.C. SEE MAP OVERLEAF P.3. An aggressive exploration program has been planned for 1996.

Previous exploration on the Gold claims located five gold geochemical and several copper anomalies reflecting underlying gold veins, sulphide bearing shears or massive sulphide mineralization. Work included trenches, pits and two short adits of, upper adit 80 metres long, lower adit 100 metres long, examining the Tuscarora 2 metre wide shear mineralized with gold, silver, arsenic copper and molybdenum. A strong geochemical soil sample gold up to 150 parts gold per billion, arsenic and copper anomaly has been defined in the northeastern portion of the claims where geophysical surveys located a strong magnetic anomaly with a strong coincident electromagnetic conductor. The initial phases of exploration by U.S. Platinum on the Gold claims will include:

- prospecting, soil sample survey and geological mapping in the largely unexplored southwestern portion of the claims. This work is to follow up on anomalous gold copper values located in previous reconnaissance work;
- backhoe trenching on three targets work;
- plus a minimum of 2,000 feet of diamond drilling to follow up on these target areas.

Chris J. Sampson, P.Eng., consulting engineer, with many years of successful exploration in the Bralorne Pioneer camp will direct the field work. Mr. Sampson is also directing the Bralorne Pioneer programs which is of substantial benefit to the company.

U.S. Platinum also holds 100% of the 12-unit Clay 1 through Clay 8 claims, 40 miles north east of the town of 100 Mile House, Clinton Mining District, B.C. is held under option which can be exercised by the issue of 100,000 shares, subject to a 2% net smelter return royalty to the vendor. The main showing consists of calcite, bornite, chalcocite veinlets, with gold values, hosted in Nicola group volcanic rock formations.
