PROPERTY ACQUIRED - In the Thistle gold camp near Port Alberni, B.C. Gold Star Resources Ltd. has negotiated an option with One Resources Canada Corp. on the 7 Golden Eagle claim group located in the Thistle gold camp, Mt. McQuillan area of Vancouver Island, B.C. (SEE MAP OVERLEAF).

The claims were first staked in the 1890's to cover the source of the China Creek placer gold. Early assays from the Golden Eagle Group, as reported in Minister of Mines Reports - gave results of up to 5 oz./gold/ton. Prior to September 1985 of this year, Lode Resources held the Golden Eagle Group and reported that the most promising results from their exploration programs were obtained from these claims. Exploration located two veins, the 'Highgrade' and 'Middle' veins. They are about 400 meters apart and associated with shear zones near the contact between a feldspar porphyry intrusive and volcanic rocks of the Sicker Group. Diamond drilling and sampling programs indicated possible tonnages of 3100 tons at 0.26 oz/ton gold and 3500 tons at 0.12 oz/ton gold. A 1980 diamond drilling program consisting of 2 NQ holes and intersections of 0.27 oz/ton gold and 0.19 oz/ton gold across three feet and ran as high as 0.43 oz/ton gold across 2.5 feet. Reports on these programs suggest that the consistency of assay values along the vein, which is exposed for over 400 meters, indicate more extensive tonnages could be blocked out with further drilling.

Sample programs on the "Middle" vein in 1980 and 1983 indicate the vein may be of greater economic importance than the High Grade. Five grab samples taken during the 1980 field season had reported assays ranging from 0.58 oz/ton and 2.20 oz/ton gold and between 0.89 oz/ton and 2.09 oz/ton silver. A chip sampling program conducted during 1983 yielded assays as high as 0.548 oz/ton gold and 0.71 oz/ton silver across 1.5 feet of mineralized quartz-carbonate vein.

The north-south trending structure associated with mineralization of the "Middle" vein has been traced for a distance of at least one kilometer through the center of the claim group. Gold Star's also holds the King Solomon and Prize high grade silver properties near Oroville, Washington.

FUNDS SOUGHT FOR GOLD - M.M. Pardek, president of Gold Star Resources Ltd., has been advised by their consultant, Frank & SILVER EXPLORATION DiSpirito, P.Eng., that samples taken from the high-grade vein on the Golden Eagle claim group in the Thistle gold camp near Port Alberni on Vancouver Island, B.C., have yielded assays as high as 6.00 oz/ton gold with visible gold present. In addition, a sample taken across 3 feet assayed 1.196 oz/ton gold - this sample represents 1 foot of quartz-carbonate vein material and 1 foot from each of the hangingwall and footwall of the vein. The hangingwall portion assayed 0.105 oz/ton gold and indicates significant wall rock mineralization.

A 3-phase exploration program has been recommended by Mr. DiSpirito for the 2 known vein systems. The first 2 phases, which include detailed mapping and sampling followed by a helicopter supported diamond drilling program, will start as soon as weather conditions warrant.

Financing for these programs and for further work on the company's Nighthawk, Washington high-grade silver properties is expected to be completed early in 1986.

Gold Star's consulting engineer Frank Di Spirito has completed a study of the company's Golden Eagle Claim Group near Port Alberni, Vancouver Island, B.C. Samples taken from the "High Grade" vein have yielded assays as high as 6.00 of gold per ton with visible gold present. A sample taken across three feet assayed 1.196 ounces of gold per ton. Di Spirito has recommended a three phase exploration program to determine the mining potential of the two vein systems known to occur on the property.

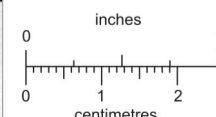
