

In compliance with your request, the exploration and development report on the Thanksgiving Property, located near Revelstoke, B.C. is completed and appended.

My investigation of the property took place in mid November, 1980 and in Mid February, 1981. During the latter visit I took samples which were submitted for analysis and which are included in the report.

The recommended program includes map preparation, a line control grid, geological mapping, geochemical and geophysical surveys, and sufficient diamond drilling to identify the nature and extent of the mineralized area on Thanksgiving No. 2 and No. 3. The estimated cost of the entire program is \$552,975.00.
