You will recall in 1955 I did certain work for Dome as your agent. A Mr. Stronach was Dome's field man at the time, endeavouring to enter into an option agreement with Trojan Explorations Ltd. and you will also recall that Mr. McLellan, who then represented Trojan, made a deal with another group without advising us and the whole transaction was nullified by his conduct.

Since that time I am advised that McLellan has fallen into general disfavour with the company and no longer has a position with it. A new group under the directorship of Mr. A.C.C. Armour has taken control. Mr. Armour has approached me to enquire whether Dome would be interested in entering into any further negotiations with respect to the property. He forwarded to me a list of the exploration development expenditures which were incurred on the property since Dome last took an interest in it and he has assured me that McLellan and that group have nothing further to do with the company.

They have appointed a new Board of Directors one of whom is a very close friend of mine, D. P. Lambert, a mining engineer who is also a Navy chum of mine and for whom I have the greatest respect and confidence. It would therefore appear from what I know of the matter that the new Board are a responsible group.

Would you care to pass this information on to those individuals in Dome who might be concerned with it so that they might advise us whether or not they still retain some interest in the property.

Thank you for your letter of January 30th in which you enclosed a copy of a letter written by Mr. Wallace of Bull, Housser & Co. together with a copy of your reply.

This may be of interest to our Company but there are a number of things we would like to look into if the figures are available.

We notice that a total of 30,000 feet of diamond drilling was completed on the property and the shaft was sunk to 165 feet with crosscutting and drifting done; we would like to have all the information on the diamond drilling together with the full particulars of the development work completed to date and any other information regarding the exploration that they might care to loan us.

All of this would, of course, be treated in complete confidence and we would expect the other party to treat it the same way until we have had a chance to look at the results of their work.

Thank you for your letter of the 5th instant. I referred your suggestion to Mr. Armour of Trojan Consolidated and I understand that he is presently giving instructions to forward the required material to Toronto. He advised me that the Company had received a similar request for information from another large mining corporation and had supplied it to them. He authorized me to so advise you.

Dear Mr. Redpath:

You may remember me from Val'd'Or days when I was at East Malartic, and latterly in my present association with Atlas Copco when visiting at Sigma Mines. I have been B.C. manager for Copco in Vancouver for the past three years. Recently I was appointed a Director of Trojan Consolidated Mines Ltd., and it is in this regard that I am writing to you.

In the past month Trojan Consolidated has changed its management, and has a new Board of Directors whose aim it is to bring the Highland Valley copper property into production as quickly and economically as possible. It has been decided to open negotiations with bona fide organizations such a Dome Exploration, with a view to having such a company take over the further development and resulting production of the property. I have been informed that Dome were interested in this property two years ago, and that an option was about completed. In my opinion, if Dome had secured the option, the property would be much further ahead than it is today, because your company is not primarily interested in promoting stock; but rather the mine itself. It is partly for this reason the Board of Trojan felt I should write on their behalf to offer your company an early opportunity to examine our records and property.

Henry L. Hill and Associates of Vancouver have in the past been retained by Trojan as Consulting Engineers. It was under their direction in 1956 a diamond drill program was carried out. As a result an underground exploration program was undertaken during 1957. This constituted sinking of a 165 foot shaft, and 850 feet of lateral drifting and crosscutting. This work has blocked out some 400,000 tons averaging 2.2% copper. There are reasonable indications to expect more, and that as far as the work has progressed, the results have been encouraging. Henry Hill recommends sinking to the 300 foot horizon and further lateral work, which is the most logical move.

I have not gone into detail, but hope that it will convey a brief picture to indicate we have an excellent property for a good mining operation, one which has been partially proven with no setbacks to date. You will find attached a brief outline of terms which we consider as a basis for a reasonable financial arrangement. All reports, maps in Henry L. Hill and Associates' office may be obtained from them for your further consideration.

It is to be hoped that you are planning to attend the forthcoming annual meeting of the C.I.M. & M. to be held here in mid April, and we shall have the opportunity of extending our traditional Western hospitality to you.

Dear Sirs:

Pursuant to our recent conversation, I set forth hereunder a tentative plan outlining the type of deal upon which Trojan Consolidated Mines Ltd. is prepared to predicate negotiations with any company interested in Trojan property in the Highland Valley area of British Columbia.

- A. Payment of \$100,000 into Trojan treasury as a gesture of good faith for which Trojan would issue 200,000 of its treasury shares.
- B. The Lessee to undertake to spend \$200,000 during the ensuing eight months following the signing of an agreement on exploration and development work.
- C. The Lessee to have an option to continue exploration and development following the eight month period.
- D. The Lessee to have an option to put the mine in production at such time as is mutually agreed upon.
- E. The first charge against profits from production shall be applied against pre-production costs and shall be pro-rated in accordance with such costs incurred by the Lessor and Lessee.
- F. Following the liquidation of all pre-production costs the profits from production shall be divided on a basis of Lessee 60% and Lessor 40%.
- G. All exploration and development work shall be under the control of the Lessee if desired.
- H. The camp, equipment and machinery now on the property shall be at the disposal of the Lessee.
- I. All camp, machinery and equipment costs incurred by either party shall be liquidated pro-rata out of profits.

Let it be clearly understood that Trojan Consolidated Mines Ltd. is prepared to consider any reasonable alternative plan.
