 Fairly poor outcrop over the entire claim area, all of it  
 volcanic flows and fragmentals with, sometimes, disseminated pyrite.  
 A few very old, widely scattered pits and small shafts, the muckpiles  
 showing disseminated pyrite and a few specks of chalcopyrite.

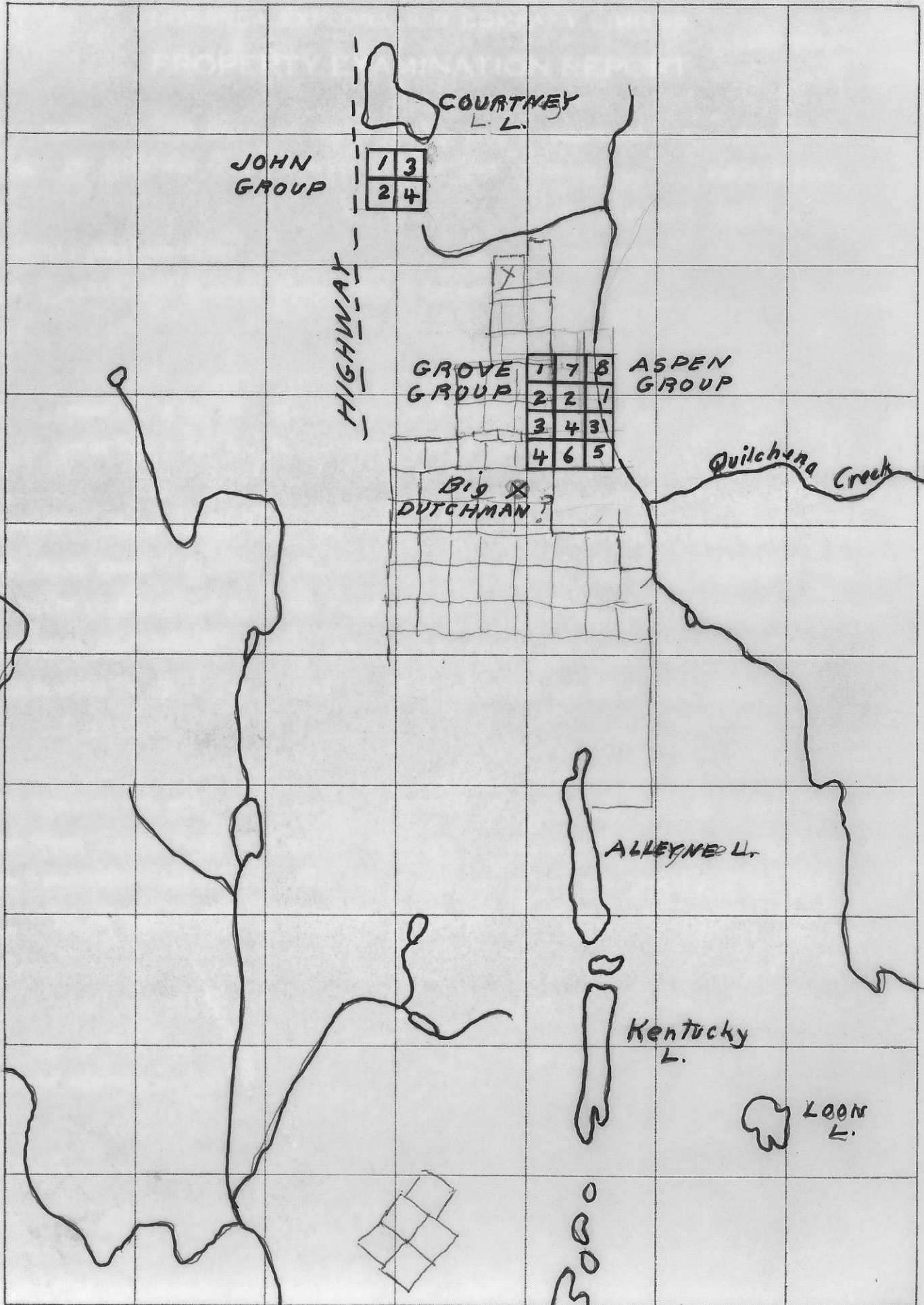
DESCRIPTION: Claims staked right and left of Government road to Pothole Creek. Mineralization along steep hillside. Considerable oxidized float exposed by bulldozer cuts in road. Solid rock exposed on ASPEN 2 and greenstain locally. Good exposures lower down road in ditch now covered by caved dirt. These copper sulfides, chalcopyrite and chalcocite, exposed in ditch for 50 feet (?) when bulldozer improved road recently.

GENERAL REMARKS AND RECOMMENDATIONS: I arranged with Road Engineer to repair this road and clean out ditches with bulldozer. As there is considerable ice on road now, it will be some time before bulldozer cleans out ditch, and before one cave-in is bridged.

Ernie Johnson knows property and occurrence of mineralization.
