## SULTAN MINERALS INC. [SUL-CDNX] 13,680,835 SHS.

NEW KENA GOLD ZONE FOUND - Arthur. Troup, P.Eng., president,  
Sultan Minerals Inc., reports the  
discovery of a new mineralized area in the Gold Mountain Zone on its 100% optioned Kena property, southeast BC. The Gold Mountain Zone lies within a Jurassic age body of Silver King Porphyry rocks having an average dimension of eight by 1.2 km. These porphyritic rocks are historically known to have a high background gold content and are currently the main focus of exploration on the Kena property.

A detailed soil-sampling program is currently underway on this zone and results to date show anomalous gold concentrations in soils over an area 2.1 by 0.9 km. The anomalous zone overlies the Silver King Porphyry and adjacent rocks and is geologically identified by visible shearing and an increase in sulphide content.

Prospecting of the Gold Mountain Zone has located a number of outcrop exposures over the soil anomaly. Rock chip and grab samples from these rock exposures show significant gold concentrations over a 1,000 metre by 400-metre area. Assays are reported in the table OVERLEAF P.1.

Peter E. Walcott & Associates has been contracted to conduct an induced polarization survey to better define the extent of the Gold Mountain mineralization.

On the Kena Gold Zone logging and plotting of drill sections is currently underway. Detailed diamond drill core studies of numerous holes drilled previously on this zone, plus surface structural geological mapping, has pointed to a new and important structural orientation that appears to control mineralization. Structural geologist David Rhys of Panterra Geoservices Inc. has completed a brief structural mapping program in this area to locate and define these mineralizing structures. Results from re-modelling the Kena Gold Zone are expected by mid-November.

At the Cat showing chalcopyrite and malachite mineralization occurs in a brecciated diorite / andesite unit. Surface sampling in 1999 returned gold values of 1.14 grams/tonne and copper values of 0.66% over 10.75 metres. Excavator trenching to better expose bedrock has been done to investigate the mineralized structures. Rock chip sample assays from this trench are pending.

CONTINUED FROM PAGE ONE - The geological unit hosting the Cat showing has been traced to the Shaft showing, located 700 metres southeast, where 1999 sampling returned 5.64 grams gold/tonne and 0.95% copper over 12.0 metres. Detailed geological studies (including alteration assemblages) suggest the geologic unit hosting the Cat and Shaft showing was intersected in former drill hole TK87-46 located a further 700 metres southeast. Visible gold was discovered by Sultan in un-sampled sections of TK87-46, and assay results returned 4.18 grams gold/tonne over 13.19 metres from this hole.

Three significant mineralized zones have now been identified by this years' exploration program on the Kena property: the Gold Mountain Zone, the Kena Gold Zone and the Shaft/Cat Zone. Exploration efforts are currently being focused on the Gold Mountain Zone where both soil and rock values indicate widespread gold mineralization. This discovery is believed to represent an important new style of mineralization that has bulk-tonnage potential.

Excavator trenching has begun on Gold Mountain in the area around 11+00N, 3+50E where a 2 metre chip sample assayed 2.71 grams gold/tonne. An expanded trenching program is planned upon completion of the induced polarization survey. Trenching will be followed by diamond drilling expected to start late November.
